SHOW RULES Please read these rules carefully.

1. Entries shall be in accordance with the schedule and be approved by classification and inspection.
2. Exhibitors need not be members of The Gesneriad Society, Inc., but must be members of the National Capital Area Chapter of the Gesneriad Society.
3. Entries, with a completed entry sheet, will be accepted from 9:30 AM to 10:30 AM. Entry sheets should be submitted to Bill Schmidt by email at Schmidt.wc@verizon.net by September 10th. Entry sheets submitted the day of the show will be accepted at the discretion of the show chair.
4. An exhibitor is limited to one specimen of the same plant per class in the Horticulture Division. An exhibitor may submit more than one entry per class, provided each entry is a different species, cultivar or hybrid, unless otherwise prohibited. Exhibitors are limited to seven entries in the overall show.
5. All plants in the Horticultural classes must be grown by the exhibitor and have been in the Exhibitor's possession for at least three months prior to the show. This rule does not apply to plant material used in arrangement classes of Division II.
6. All exhibits in flowering classes must have at least one fully opened flower.
7. Seedpods or fruit are permitted on all gesneriads entered in the Horticulture Division. These may be regarded as enhancements of, or detractions from, flowering plants by the judges.
8. No particular type of container is specified for the Horticulture Division. Whatever is used should be clean. A protective container or cover made of transparent material to shield delicate plant material from dry air or cold drafts may be used for any exhibit requiring it. Such plants may be judged uncovered.
9. All plants must be free of insects and disease.
10. The Gesneriad Society standard competitive judging will be used. (This means that there is only one of each ribbon awarded for each class.) Awards will be made according to the following point scores:
1st, blue ribbon, 90-100 points;
2nd, red ribbon, at least 80 points;
3rd, white ribbon, at least 70 points.
11. The cash awards for Best in Divisions and/or individual species/other awards are given only to exhibits scoring 90 points or over.
12. The award for Best Gesneriad in Show in the Horticulture Division is given for horticultural perfection. A plant must score 95 points or over to be considered for this award. (Saintpaulias excluded from this award).
13. The Chapter will endeavor to protect all exhibits but assumes no responsibility for loss or damage. All entries must be removed before departure from the meeting which ends at 1:00pm.

DIVISION I HORTICULTURAL

SECTION A

New World Gesneriads in Flower — Tuberous

Class 1 Sinningia species or cultivars

Class 2 Other tuberous Gesneriads (Chrysothemis, Nautilocalyx, etc.)

SECTION B

New World Gesneriads in Flower — Rhizomatous

Class 3 Rhizomatous gesneriads (Achimenes, Eucodonia, Gloxinia, Seemannia, Kohleria, Smithiantha, etc.)

SECTION C--New World Gesneriads in Flower — Fibrous-Rooted

Class 4 Fibrous rooted gesneriads (Codonanthe, Columnea, Episcia, Gesneria, Nematanthus, etc.)

SECTION D--Old World Gesneriads in Flower

Class 5 Primula

Class 6 Streptocarpus, and subgenus Streptocarpella

Class 7 Saintpaulia species or cultivars

Class 8 Other Old World gesneriads (Aeschynanthus, Petrocosmea, etc.)

SECTION E--Gesneriads Grown for Ornamental Qualities Other Than Flowers

Decorative fruit and calyces are permitted, but no flowers or buds showing color. A plant should have some special quality of color, texture or growth habit to be entered in this section.

Class 9 New World gesneriads with ornamental qualities

Class 10 Old World gesneriads with ornamental qualities, including variegated and/or distinctive foliage (ie. chimera, spotted) Saintpaulia.

SECTION F--New Gesneriads

This section is for introductions made within the last five years. Exhibitor must provide a card giving educational information such as name of hybridizer, collector, place of origin, special cultural requirements.

Class 11 In flower or not in flower.

SECTION G--Lesser-Known Gesneriads Seldom Seen in Shows

Exhibitor must provide a card giving educational information such as habitat, source, and special cultural requirements.

Class 12 In flower or not in flower

SECTION H--Trained or Sculptured Gesneriads

An educational 3"x5" white card should be included, stating what training the exhibit received and how the exhibit is to be viewed (all sides or from the front).

Class 13 Bonsai, topiary, espaliered, or other styles.

SECTION I--Gesneriads Grown by a Novice

A Novice is anyone who has never won a blue ribbon in the Horticulture Division of a gesneriad flower show

Exhibitors wishing novice status for the Horticulture Division may not enter other horticulture classes

Class 14 Gesneriads in flower

Class 15 Gesneriads grown for ornamental qualities other than flowers

SECTION J--Collections of Gesneriads

Class 16 A grouping of 3 to 5 different plants in flower or grown for ornamental qualities, or in combination.

Exhibitor is encouraged to stage the plants as a unit. Exhibitor must provide a card with identification of plants.

DIVISION II ARTISTIC

Gesneriads must predominate. No artificial plant material allowed. Other live and dried material permitted as indicated. Accessories are optional. Saintpaulia permitted in all classes. Gesneriads used must be identified on an accompanying card. Reservations for entries in the Artistic Sections must be made with Bill Schmid, 804-349-7683 Schmid.we@verizon.net by September 10 th . Only one entry per exhibitor per class.

SECTION K—Arrangement of Fresh Cut, Dried/Treated, and/or Growing Plant Material with or without blossoms. Limit of 2 entries per class.

Class 17 “Mythological Creature” - Cultures have long used creatures in the wild as inspiration for myths and folktales. Choose a mythical creature of land, water, or air to reflect in your design. Name and briefly describe the creature on an educational card. Staged in an 8”H x 8”W x 6”D niche.

Class 18 “Basilisk” This venomous, serpent-like creature is known for its deadly gaze and toxic breath. It is often referred to the “King of Serpents” due to its size and power. Reflect power and fear of this evil creature. Staged in a 12”H x 12”W x 10”D niche.

Class 19 “Winged Horse” Winged horses appear in the mythologies of many cultures. Reflect the power, freedom, and beauty of a winged horse. A free standing design not to exceed 12” in any dimension. Viewable from all sides. Name and briefly describe on an educational card.

SECTION L--Container Planting of Growing Material Limit of 3 entries.

Class 20 Terrarium, Tray/Dish Landscape or Natural Garden.

DIVISION III THE ARTS

All entries must feature gesneriads in some form. Each entry must have been made by the exhibitor. Reservations for entries in the Arts must be made with Bill Schmidt, 804-349-7683, Schmidt.wc@verizon.net by September 10 th . Limit of 5 entries per class. Only one entry per exhibitor per class.

SECTION M--Photography.

The subject must be identified on the entry card. Prints should not exceed 8” x 10”. Exhibitors must provide an easel for prints 5 x 7 or over.

Class 21 Color or Monochrome print of a Gesneriad or parts of a Gesneriad (flowers, fruits, foliage, etc.)

SECTION N—Arts and Crafts Representing Gesneriads

Class 22 Painting, drawing, needlework, textile or other arts and crafts

Class 23 Educational exhibits featuring gesneriads
