What-

- ◆ Creation may not be traced from other artists’ work or traced from photographs.
- ◆ Each entry must have the completed form signed by a parent or guardian attached to the back of the poster. (see form to the right)
- ◆ Must Include: **“One Water”** must appear on the front of the poster.
