H2Ohio Update By Kate Myers

We have begun to make payments for the Voluntary Nutrient Management Plan Development practice which is \$2 an acre. As soon as producer VNMPs are approved by the board, producers need to initial a verification sheet and then will be ready to receive payment. If you have not submitted your VNMP, please do so ASAP or reach out to Kate Myers to update her on the status of your VNMP (or CNMP). If you have submitted your VNMP and have not initialed and submitted a verification sheet, please also do this so we can process payment.

VNMPs need to be submitted and approved prior to application of nutrients this spring unless you have explicitly discussed your situation with Kate. This is to ensure your recommendation rates are compliant with Tri-State Fertilizer Recommendations and will be eligible for all practices you are enrolled in.

Please continue to submit documentation of all practices. To find all supporting documentation needed, please review

both the BMP Specification Sheets and the Verification Sheets that are associated with each practice. By July, VRT and Subsurface Placement payments should start to be able to go out if all documentation (including the corresponding verification sheet) is submitted. You can find the verification sheets under the H2Ohio tab on our website or contact Kate for more details. Year 2 Funding:

Funding for year 2 (FY21-22) of the H2Ohio Program has been secured. As of now it is expected that agreement extensions will be ready in July so be on the look out for more information/ contact from Kate to sign the agreement extension.

College Scholarship Being Offered

The Van Wert SWCD is offering one \$500 scholarship to college students studying agriculture, natural resources, or closely related fields at an Ohio college or university during the 2020/21 academic year. Recipients of the scholarship must have completed their freshman year, and must be a Van Wert County resident.

Scholarship applications are due by May 7, 2021. The Scholarship Committee of the SWCD will review all applications and the recipient will be announced in June. Scholarship money will be sent directly to the recipient's college or university at the beginning of the academic year.

Criteria for determining the recipient will be area of study, grades, activities, leadership, and commitment to conservation practices. The SWCD reserves the right to refuse any applications not meeting requirements.

Applications and two reference forms need to be completed and sent to the office by the deadline of May 7. The forms are available at the office or on the Van Wert SWCD website.



American Farmland Trust

American Farmland Trust, in cooperation with Danone North America, NRCS, NFWF, and Sustainable Environmental Consultants, is looking for supply chain farmers in the dairy feed shed to receive a free Farm Report and Sustainable Continuous Improvement Plan (SCIP). This report and plan will be used to benchmark farm practices and work to implement improved soil health management. Through participation in this program, farmers will receive one-on-one engagement with an American Farmland Trust representative for

continuous support and education. Farmers will also gain access to funding support channels to implement their personal SCIP. This project is a collaborative effort between many organizations designed to support farmers. Along with giving the students a tree they also had a class presentation and were 12. We have also been able to utilize Zoom and given information on their new tree that they can plant at home.

Trees contribute to their environment by providing oxygen, improving air quality, climate amelioration, conserving water, preserving soil, and supporting wildlife. During the process of photosynthesis, trees take in carbon dioxide and produce the oxygen we breathe.

As trees grow, they help stop climate change by removing carbon dioxide from the air, storing carbon in the trees and soil, and releasing oxygen into the atmosphere. Trees provide many benefits to us, every day.
