## **H2Ohio Update**

Summer is in full swing, which means H2Ohio can officially begin making 2022 crop year payments! The first set of payments can be approved to anyone enrolled in the phosphorus application or placement practices once ALL the verification requirements are fulfilled. I do my best to send out information the program. If you are not receiving my monthly letters or remind texts, please let me know and I can add you to my mailing list.

#### **Updates for 2022:**

The most recent update to the program is regarding the cover crop and manure program. The deadline to have manure incorporated and cover crops seeded is **November 1**st.

Producers using Bin Run Seed MUST submit samples for noxof reminders and new updates to ious weed seed testing PRIOR to seeding the cover crop. The cover crop will not be approved to plant until it has been cleared of any noxious weed seed.

# **New Incentive payment**

Any producer that decides to inter-seed cover crops by September 30th will receive an additional \$10 an acre. You must enroll for this practice by August 1st!
