Supervisor Election Notice

The Van Wert SWCD will be holding an election only this year due to the restrictions with Covid 19. 1 member will be elected for a 3 year term of office. County residents and landowners have 2 options for casting a ballot.

- 1. Contact the office in writing beginning October 26, 2020 requesting an absentee ballot. All ballots must be received by December 8, 2020.
- 2. Cast a ballot at the District office by 3:30 p.m. on December 8,2020.

To be eligible to vote, you must be of legal voting age (18 years) and reside or own land within the District.

Van Wert SWCD is a legal subdivision of state government that provides natural resource management assistance to county landowners and other units of local government. The District is funded by the Van Wert County Commissioners and county funds are supplemented by funding from the Ohio Department of Agriculture, Division of Soil and Water Conservation. This District is governed by a five member board of county residents.

Statewide Milkweed Pod Collection Runs Sept 1 – Oct. 30



Due to the in monarch butterfly (Danaus plexippus) popula-

Pollinator Habitat Initiative (OPHI) and local Soil & Water Conservation Districts are again seeking public involvement to collect common milkweed (Asclepias syriaca) seed ponds from established plants September 1 through October 30. This is an annual event and we hope you can participate !

The seeds will be used to establish new plantings and additional habitat for the monarch butterfly throughout the buckeye state. These future plantings will increase the food source for the caterpillar stage.


Seed pods from common milkweed should be collected **ON-**

LY WHEN THE PODS ARE drastic decline **DRY AND BROWN-GREY** in color. If the center seam pops with gentle pressure, they can be picked. The seeds in green pods will not be viable and tions, the Ohio won't be able to be used. Be patient and don't collect too soon !

It is best to collect pods into paper bags. Avoid using plastic bags because they can allow mold to develop. It is recommended to wear disposable gloves when picking the handling pods. Ideally, it is recommended to leave at least 50 percent of the seed crop at a given site to allow for natural recruitment and reeneration of the native population the next growing season. There are situations where total collection can occur ie. If the field or area will be mowed

completely or the area will be converted for crop or development. A collection container is located outside the door of the Van Wert SWCD, 1185 Professional Drive, Van Wert.

H2Ohio Update

178 producers in Van Wert County have signed up for the H2Ohio program with more than 104,000 acres enrolled across the county. The Van Wert SWCD would like to thank all producers in the program for their cooperation in getting their applications and contracts completed.

H2Ohio Program Timeline:

Now through October 31st: submit Voluntary Nutrient Management Plans (VNMPs) to Kate for approval. These plans must be approved by the Board of Supervisors at the December board meeting so be sure to allow for enough time for any possible corrections. The sooner the better!

Now through Summer 2021: implementation of 2021 BMPs. See below for which BMPs can be started this fall.

BMPs that can start this fall that fall under the 2021 crop year:

Variable Rate Phosphorus Application

Subsurface Phosphorus Placement

Conservation Crop Rotation (Small Grains and Forages) Drainage Water Management structures

All remaining H2Ohio BMPs can be implemented beginning Spring 2021.
