**BASS TOURNAMENT RULES**

1. ALL FISHERMEN MUST HAVE A CURRENT ALABAMA FISHING LICENSE
2. NO MORE THAN TWO FISHERMEN MAY FISH IN THE SAME BOAT
3. BOATS MUST CONFORM TO ALL STATE & FEDERAL REGULATIONS & MUST HAVE AN OPERATING LIVEWELL.
4. **NO ALCOHOLIC BEVERAGES ALLOWED UNTIL WEIGH-IN IS CLOSED.**
5. LIFE JACKETS MUST BE WORN WHILE OUTBOARD ENGINE IS IN OPERATION.
6. ANY ATTEMPT TO WEIGH ANY FISH LESS THAN THE 12" MINIMUM WILL RESULT IN LOSS OF THE SHORT FISH, AS WELL AS THE LARGEST FISH IN THE CONTESTANTS CREEL. FISH WILL BE MEASURED ON A "GOLDEN RULE" MEASURING BOARD.
7. A . 20 PENALTY WILL BE DEDUCTED FROM THE ANGLERS TOTAL WEIGHT FOR EACH DEAD FISH.
8. ONLY LARGE MOUTH OR SPOTTED BASS MAY BE WEIGHED.
9. ONLY ARTIFICIAL LURES MAY BE USED WITH CASTING, SPINNING, OR SPIN CAST EQUIPMENT. (NO LIVE BAIT, TROLLING, SPEARING, SNAGGING, FLY RODS OR JIGGER POLES.)
10. SCORING WILL BE TOTAL WEIGHT OF EACH BOATS CREEL.
11. TIES WILL BE BROKEN BY LARGEST FISH IN CONTESTANTS CREEL.
12. NO CONTESTANT MAY FISH WITHIN 50 YARDS OF ANOTHER CONTESTANTS BOAT WITH ANCHOR OUT.
13. NO CONTESTANT MAY LEAVE THE BOAT AFTER TOURNAMENT BEGINS.
14. ALL CONTESTANTS MUST RETURN TO LANDING BY WEIGH-IN TIME OR THEY WILL BE DISQUALIFIED.
15. ALL FISH WEIGHED WILL BECOME PROPERTY OF MONROE COUNTY BASS ANGLERS AND WILL BE RELEASED.
16. IN CASE OF PROTEST OR RULES VIOLATIONS, CONTESTANTS AGREE TO POLYGRAPH TESTING. FAILURE TO TAKE OR PASS POLYGRAPH TESTING WILL RESULT IN IMMEDIATE DISQUALIFICATION. TEST WILL BE GIVEN AT THE DISCRETION OF THE TOURNAMENT DIRECTOR. ALL DECISIONS MADE BY THE MONROE COUNTY BASS ANGLERS TOURNAMENT DIRECTOR ARE FINAL.
17. ALL BOATS, LIVEWELLS, AND COOLERS WILL BE CHECKED BEFORE LAUNCHING.
18. TOURNAMENT WILL BE HELD RAIN OR SHINE.
19. **FISH WILL BE TRANSPORTED IN BAGS PROVIDED BY MONROE COUNTY BASS ANGLERS ONLY. FAILURE TO DO SO WILL RESULT IN DISQUALIFICATION.**
