**BASS TOURNAMENT RULES**

1. **TOURNAMNET IS OPEN TO ONE ADULT AND ANGLERS 15 YEARS OLD AND YOUNGER.**
2. BOATS MUST CONFORM TO ALL STATE & FEDERAL REGULATIONS & MUST HAVE AN OPERATING LIVEWELL.
3. **NO ALCOHOLIC BEVERAGES ALLOWED!**
4. LIFE JACKETS MUST BE WORN WHILE OUTBOARD ENGINE IS IN OPERATION.
5. THERE IS NO SIZE LIMIT
6. A 40 PENALTY WILL BE DEDUCTED FROM THE ANGLERS TOTAL WEIGHT FOR EACH DEAD FISH.
7. ONLY LARGE MOUTH OR SPOTTED BASS MAY BE WEIGHED.
8. ONLY ARTIFICIAL LURES MAY BE USED WITH CASTING, SPINNING, OR SPIN CAST EQUIPMENT. (NO LIVE BAIT)
9. SCORING WILL BE TOTAL WEIGHT OF EACH BOATS CREEL.
10. TIES WILL BE BROKEN BY LARGEST FISH IN CONTESTANTS CREEL.
11. NO CONTESTANT MAY FISH WITHIN 50 YARDS OF ANOTHER CONTESTANTS BOAT WITH ANCHOR OUT.
12. NO CONTESTANT MAY LEAVE THE BOAT AFTER TOURNAMENT BEGINS.
13. ALL CONTESTANTS MUST RETURN TO LANDING BY WEIGH-IN TIME OR THEY WILL BE DISQUALIFIED.
14. ALL FISH WEIGHED WILL BECOME PROPERTY OF MONROE COUNTY BASS ANGLERS AND WILL BE RELEASED.
15. IN CASE OF PROTEST OR RULES VIOLATIONS, ALL DECISIONS MADE BY THE MONROE COUNTY BASS ANGLERS TOURNAMENT DIRECTOR ARE FINAL.
16. ALL BOATS, LIVEWELLS, AND COOLERS WILL BE CHECKED BEFORE LAUNCHING.
17. TOURNAMENT WILL BE HELD RAIN OR SHINE.
18. **ALL FISH WILL BE WEIGHED IN BAGS PROVIDED BY MCBA**
