OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Sponsor

The Stanley Scuba, Sailing & Adventures 100K Celebration Giveaway (“Giveaway”) is sponsored and administered by Stanley Scuba, Sailing & Adventures LLC, Missouri (“Sponsor”).

YouTube, Google and Amazon are not sponsors or administrators of this Giveaway and are not responsible for its administration.

2. Giveaway Period

The Giveaway begins at **0900 Central Time on August 1, 2026** and ends at **11:59 p.m. Central Time on August 8, 2026** (“Giveaway Period”).

Only eligible individuals subscribed to the Stanley Scuba, Sailing & Adventures “Join the Adventure” email list at the close of the Giveaway Period will be included in the drawing.

Sponsor’s records will serve as the official record for determining eligible entries.

3. Eligibility

The Giveaway is open only to legal residents of the 50 United States and the District of Columbia who:

1. Are 18 years of age or older at the time of entry; and
2. Have a valid physical shipping address within the United States capable of receiving the prize through Amazon.

P.O. boxes are not eligible for prize delivery.

Individuals who were already subscribed to the Stanley Scuba, Sailing & Adventures “Join the Adventure” email list before the Giveaway began are automatically entered, provided they otherwise satisfy these Official Rules.

There is no need for an existing subscriber to subscribe again.

Limit one entry per person, regardless of the number of email addresses controlled by that person.

No purchase or payment is necessary.

You are not required to subscribe to the Stanley Scuba, Sailing & Adventures YouTube channel, watch a particular video, like or comment on a video, share content, purchase an OrcaTorch product or take any other action on YouTube or another social media platform to enter or increase your chances of winning.

An entrant who unsubscribes before the Giveaway Period closes will no longer be subscribed to the “Join the Adventure” email list at the time eligibility is determined and therefore will not be included in the drawing.

6. Prize

One winner will receive the opportunity to select **one eligible OrcaTorch product available through the designated OrcaTorch Amazon storefront with a listed item price of \$150 or less before applicable sales tax.**

Approximate Retail Value: Up to \$150.00.

Sponsor will purchase the winner’s selected eligible product through Amazon and arrange for Amazon to ship the product directly to the verified winner.

Sponsor will pay applicable sales tax and standard shipping charges associated with fulfillment of the prize.

The winner must select a product that is available and that Amazon is able to deliver to the winner’s verified physical U.S. shipping address.

Product availability, pricing and delivery eligibility are subject to change.

If the winner’s initial selection is unavailable, exceeds the \$150 listed item price limit, or cannot be delivered to the winner’s address, the winner will be asked to select another eligible OrcaTorch product.

The prize is nontransferable and no cash alternative will be offered.

7. Winner Selection and Odds

After the Giveaway Period closes, Sponsor will identify eligible individuals subscribed to the Stanley Scuba, Sailing & Adventures “Join the Adventure” email list and randomly select one potential winner from that eligible pool.

The random drawing is expected to occur on or about **August 9, 2026.**

Each eligible person will receive one entry.

Odds of winning depend on the total number of eligible entries.

Sponsor's decisions concerning eligibility, administration and winner selection are final, subject to applicable law.

8. Winner Notification and Verification

The potential winner will be contacted using the email address associated with the selected entry.

The potential winner must respond within **72 hours** after Sponsor sends the notification.

Sponsor may request information reasonably necessary to verify eligibility, including the potential winner's full name, confirmation of age and U.S. residency, and a valid physical U.S. shipping address.

Sponsor will never require a winner to pay a fee, purchase anything, provide credit card information, purchase gift cards or pay shipping charges in order to claim the prize.

Recipients may unsubscribe from future marketing communications using the unsubscribe mechanism provided in those communications.

Sponsor will request additional personal information only from a potential winner as reasonably necessary to verify eligibility and fulfill the prize. This information may include the potential winner’s name, age and residency confirmation, and physical shipping address.

The verified winner’s shipping information will be provided to Amazon as necessary to purchase and deliver the prize.

Sponsor will not sell personal information collected in connection with this Giveaway.

Personal information may be retained for a reasonable period as necessary for Giveaway administration, fraud prevention, recordkeeping, accounting and compliance with applicable legal obligations.
