Message from the Council President By Christi Wise

People of God, the 2021-2022 ministry year has been one of building on the firm foundation we have established at St. John's. At the Fall Council Huddle, we were grateful to be meeting in person and making plans for the coming year. We are so happy to be secure in what is likely the most critical component of our firm foundation: a community who can continue to safely gather in Christ.

This year we also built on a firm foundation financially as we passed a balanced budget for 2022, the second year in a row. And, we formed several teams who successfully led efforts to take care of the church operations, with regular updates to the Church Executive Committee.

We are grateful to the following leaders and teams for their efforts and briefly highlight their accomplishments below:

Church Operations

Facility Care: Al Swanson (chair), Bill Kaspar, John Hauser, Lisa Hogarth

- Created a master plan of short and long term needs with cost estimates and prioritization.
- Followed through on the plan by replacing the refrigerator and gathering bids for resurfacing the parking lot.
- Transitioned tenants in the apartment, maintaining high level of occupancy.

Finance: Cindi Rachowicz (chair), Michel Hauser, Jason Shutters

- Automated and simplified payroll.
- Restaffed offering counters (thank you volunteers).
- Published monthly dashboards to support Exec and Council leadership needs.
- Followed through on our Green Team initiative to source energy from clean sources (wind) by switching providers. Advisors from Go Green Wilmette assisted.

Space Sharing: Mylene Pollock (chair), Greg Oreskovich, Katie Hauser, Chad Johnson

- Created a strategy and framework to reach out to the neighborhood, positioning the space at St. John's as a place for doing good.
- Identified future avenues to target organizations who might find St. John's space useful.

Oktoberfest: Peter Hauser (chair), Jeff Danielsen, John Hauser, Chris Maglocci, Mylene Pollock

- Envisioning an event on 10/1/22 in the St. John's parking lot with live music, food, and drinks.
- Looking for others to pitch in on preparation and/or participation on the day of the event.

In addition to the work of operating the church, we formed several teams to advance strategic initiatives that are important in shaping the future of St. John's. These teams shared progress and sought input from the Church Council.

- Successfully re-established weekly Children's Church.

• Identified through candidate search, interviewed, and onboarded Luke Duroc-Danner, who began at St. John's on June 13, 2022.

Mission & Vision: Christi Wise (chair), Jeff Danielsen, Michel Hauser, Pr. Allison

- Created a Draft Strategic Plan (see page 4) based on congregational and Council input.
- Hosted small group discussions during Lent for congregation members to respond to the draft and offer input.
- Led the congregation in further reflection at a special worship service in May.
- Plans to lead further discussion and reflection this fall with the goal of adopting a final draft at the January 2023 congregational meeting.

Sacred Organizing Learning Community: Pr. Allison (chair), Emily Chittajallu, Michel Hauser, Anne McGivern, Sabine Scholz, Christi Wise

- Joined with members of other Wilmette houses of worship to learn and carry out the arts and practices of faith-based community organizing, including having uncommon conversations that build deeper relationships and stronger community networks.
- Identified teenage mental health struggles as a widespread issue in our area. Connected the pressures teens experience on the North Shore to the characteristics of white supremacy culture (see page 11) and the work of becoming an anti-racist community.

Reconciling in Christ (RIC): Chris Maglocci (chair), Molly Bolash, Luke Rasmussen, Alla Rusz

- Began envisioning a process for St. John's to become RIC (fully LGBTQ affirming).
- Facilitated a SafeZone training for the congregation to learn about LGBTQ identities.
- Placed projects on hold for the spring of 2022 and will reform the team in the fall.

It has been a blessing to me to be a part of the leadership team for the last 3 years. After participating on the Call Committee, I was motivated to support the welcoming and onboarding of our new Pastor, Allison Bengfort. As Vice President for two years and as President this past year, it has been an exciting time to continue the commitment to building on a firm foundation at St. John's.

Return to In-Person Activities

As we have continued to navigate COVID-19, the health and well-being of our most vulnerable people have remained a priority. Our Re-Entry Team has carefully guided our return to inperson activities to keep everyone as safe as possible while also offering opportunities for connection. In June of 2021, we returned to in-person worship followed by outdoor coffee hour while continuing to offer a simultaneous online worship option. Children's Church moved from online-only to hybrid in-person/online in August.



New Livestreaming System

In July, we installed a new livestreaming system, allowing us to continue offering a high-quality online worship option for those who are homebound, sick, or out of town. The new system includes 3 webcams in the sanctuary, improvements to our sound system, and a control center downstairs. In addition to streaming our services live online through Zoom and YouTube, the

system also records all our services, storing them on our YouTube channel for later viewing. The funding for this project was provided by the Doug Peters estate as well as by gifts in honor of Kevin Beretta, The Rev. E. C. Farewell to Robert McConnell

On September 19, we bid farewell and Godspeed to our beloved Organist and Music Director, Robert McConnell, as he accepted a new position at Church of the Holy Spirit Episcopal in Lake Forest. To celebrate his 11 years of faithful service and let him know how much he means to us, we gathered for a party on the church lawn after worship. Among the parting gifts we offered him was money toward the purchase of a new bike.

Interim Music Minister

On October 10, St. John's hosted an author event with Elle Dowd, author of *Baptized in Tear Gas: From White Moderate to Abolitionist*. At the event, Elle (pronounced "L," she/her) shared about her background, gave a live reading of an excerpt from the book, answered questions, and signed copies of the book for those in attendance. Several members and friends of St. John's met a week later to continue discussing the abolition of the police and carceral system.



Stewardship Season: Building on a Firm Foundation

Building on the firm foundation of God's love that has made possible the many successes of our congregation, our 2021 stewardship season focused on increasing offerings for the purpose of sustaining vital ministry, practicing liberating love, and supporting our facilities. By sharing stories of why we give and how the ministry of St. John's has an impact on so many lives, we connected more deeply with one another and stepped into the divine flow of generosity. We were able to increase intended offerings for 2022 by \$155/week, and we exceeded our goal of collecting 55 intent cards. Thank you for your generosity!


Christmas In-Person & Online

The Fast I Choose: Confronting White Supremacy Culture

During the season of Lent, we took a hard look at the culture of white supremacy that permeates our lives. Though we do not consider ourselves white supremacists, we recognize that we have internalized cultural norms that perpetuate injustices in our community. Over the course of the season, we examined 12 toxic characteristics, or "poisons," of white supremacy culture (see Tema Okun's article, "White Supremacy Culture -Still Here," for more information). Through preaching, liturgy, and weekly handouts, we explored the symptoms of each of these poisons as well as the antidotes. Each week, we repented of the systemic sin of racism and committed to mindfully choosing alternative pathways and practices for being in community together. Art to the left by Melanie Walby.

Holy Week at St. John's

For the first time since the spring of 2019, we were able to celebrate Holy Week in person. Our Palm Sunday service on April 10 featured preaching by Metro Chicago Bishop Yehiel Curry, and Student Pastor Derek Stienmetz preached and coled the Maundy Thursday service with Pastor Allison. On Good Friday, we gathered for a dramatic Tenebrae service, and on Holy Saturday, our Youth & Family Ministry Team hosted our 4th annual Intergenerational Easter Vigil. Our joyful Easter Sunday service featured string quartet and was followed by an Easter Egg Hunt and Coffee Hour celebration.



Spring Activities Continued...

First Communion & Opening the Table

During the season of Easter, Student Pastor Derek offered a three-week First Communion class for children. Six children completed these classes and received their First Communion on May 15. We are so happy to have officially welcomed these children of God to the Lord's Supper!

Given our congregation's firm conviction that all are welcome at Christ's table without exception, we are now adjusting our practices to offer communion to people of all ages, including young children. Even as we open the table to all, we will continue to offer Communion education for our youth on a regular basis.



Family Promise

Family Promise guests returned to St. John's May 1-21. We had the opportunity to host two families who are housing insecure, providing them a safe environment to have dinner, visit, and sleep. The St. John's youth held a welcome party (pictured) for our guests upon their arrival on May 1st. During the remainder of their stay, the families spent the daytime hours at the Family Promise Day Center receiving supportive services and then returned to St. John's for the evening. Our eager volunteers took turns preparing meals and visiting with our guests. How blessed we are to be able to participate in such a caring and important ministry!

Year-to-Date Budget Commentary

Surplus of \$5.5k in 2021

Our revenues came in under budget in 2021, due primarily to the inability to hold fundraisers and secondarily to having fewer facility rentals and slightly lower giving than expected. Fortunately, our maintenance, compensation, and ministry expenses were below budget, offsetting the shortfall in revenues and allowing for a \$5,482 surplus in 2021. This surplus has been applied to our cash reserves.

Balanced 2022 Budget

The 2022 budget reflects a modest increase in offerings compared to the 2021 actual figure. Salaries include a 3% cost of living increase. Budgeted ministry expenses are slightly less than 2021, enabling us to budget a surplus of \$449.

Currently \$13k Behind on the 2022 Budget

So far in 2022, our building rentals have increased, bringing in 165% of their year-to-date budget. Unfortunately, our offerings are only 77% of what we anticipated for the first portion of the year. While nearly all of our households are on track with their pledges, a small number of large donors have had changes in life circumstances that have put their giving on hold. We are hopeful that these pledges will be fulfilled later in the year.

Expenses through the end of May are running slightly below our budget, but with inflation, we recognize that expenses may increase during the second part of the year.

Forecasting a \$6.5k Year-End Deficit

It is challenging to give a year-end forecast given so many unknowns. If all pledges, including those currently on hold, are fulfilled in 2022, our best estimate indicates a \$6,616 deficit at the end of the year (a shortfall of 2% of our expected operating costs). We will need to make up this difference in the coming months through additional giving, building rentals, and/or fundraising.
