Introduction

This report presents a comprehensive overview of the proposed legislation concerning cannabis and hemp in Georgia for the year 2024. Compiled by the Georgia Medical Cannabis Society, this document aims to inform stakeholders, members, and interested parties of the legislative landscape as it stands on February 18, 2024.

Legislation Overview

HB 985 - Abolition of the Georgia Higher Education Assistance Corporation

- Objective: Proposes the dissolution of the Corporation, which could affect financial assistance for students in agriculture and hemp studies.
- Implications: Potential reduction in funding for students pursuing cannabis research and cultivation education.

[Update] Passed the house on 2/1/24 and as of 2/22/24 Senate Committee Favorably Reported

HB 1056 - Enhanced Penalties for Controlled Substances Violations

- Objective: Introduces stricter penalties for certain individuals involved with controlled substances.
- Implications: Increases the severity of legal repercussions for cannabis industry violations.

HB 1127 - Department of Agriculture's Enforcement Authority

- Objective: Grants the Department authority to enforce criminal laws within agricultural sectors.
- Implications: Enhances regulatory oversight in the hemp and cannabis industries.

SB 350 - Prohibition on Sale of Consumable Hemp Products to Under 21

- Objective: Aims to restrict the sale of hemp products to individuals under the age of 21.
- Implications: Aligns hemp product sale age restrictions with those of alcohol and tobacco.

SB 437 - Department of Agriculture's Enforcement Authority

• Objective & Implications: Duplicate of HB 1127, reinforcing the Department of Agriculture's enforcement capabilities.

SB 448 - Revision of the Official Code of Georgia Annotated

- Objective: Proposes a comprehensive update to the statutory portion of the Georgia Code.
- Implications: Potential modernization of laws affecting the hemp and cannabis sectors.

SR 354 - Senate Study Committee on the Effects of Cannabis Use

• Objective: Establishes a committee to investigate cannabis use effects.

HB 1286 - Georgia Hemp Farming Act

- Objective: Regulates the cultivation, production, and sale of hemp products.

HB 853 - Repeal of the Drug-free Postsecondary Education Act of 1990

- Objective: Suggests repealing drug-free requirements in higher education settings.

SB 485 - Trial upon Accusation for Certain Offenses

- Objective: Allows charging certain offenses by district attorney accusation.

SB 494 - Georgia Hemp Farming Act (Regulation of Hemp Products)

- Objective: Focuses on the regulation of hemp products, similar to HB 1286.
- Implications: Ensures consumer safety and adherence to industry standards.

HB 1322 - Georgia Hemp Farming Act; Regulate Consumable Hemp Products

- Objective: Specifies regulation for consumable hemp products under the Georgia Hemp Farming Act.
- Implications: Sets clear guidelines for the safety, quality, and integrity of consumable hemp products, ensuring consumer protection and industry standardization.
