## **QUALIFICATION FOR MEMBERSHIP**

To qualify for General Membership, the following will apply:

- An applicant must be 18 years or older.
- An applicant belonging to another club with an established USGA handicap does not have to qualify. She must pay the annual membership dues and SCGA dues.

Applicant for membership should have knowledge of golf rules and etiquette and the ability to keep up with normal play. Applicant who does not have an established handicap must qualify by:

- Completing the Qualifier Section of the Membership Application Form and submitting a Qualifier Fee of ½ of the club's yearly dues. The fee is not refundable and is applicable for a period of six months.
- Playing five games, including three games of 115 or less, played at Mile Square Golf Course with a member on a regular Ladies' Club day within six months of application.
- Upon qualifying, the applicant will submit a check or cash to cover mandatory General Membership dues and SCGA dues. Optional fees include: weekly sweeps, hole-in-one club, and WPLGASC dues.

## **GENERAL MEMBERSHIP REQUIREMENTS**

General members should:

- Have basic knowledge of USGA Rules of Golf.
- Have knowledge of golf etiquette.
- Abide by the By-Laws, Standing Rules and Local Rules of the club. Refusing or neglecting a strict and honorable compliance with the rules of the club may render a member liable for suspension or expulsion by a 2/3 vote of the club members present. No member will be suspended before charges have been made in writing, and an opportunity has been given to the member to speak to the board in her defense.
- Be willing and able to maintain speed of play.
- Have the ability to keep their own score accurately and post scores.
