

TEAM RAR LAWS FOR TEAM MEMBERS

Official Member Code of Order and Conduct

Law 1. Obedience to Command

All team members shall obey the lawful orders, directives, and decisions of Team RAR officers, command staff, and approved leadership.

Law 2. Loyalty to the Team

Every member shall remain loyal to Team RAR, its mission, its order, and its command structure. Betrayal, sabotage, or deliberate disobedience shall be considered a serious violation.

Law 3. Respect Among Members

No member shall threaten, harass, bully, or intentionally disrespect another member, officer, or leader of Team RAR.

Law 4. Protection of Team Property

All members shall protect Team RAR property, records, equipment, gear, uniforms, and any official materials from damage, theft, or misuse.

Law 5. Truthfulness in Official Matters

No member shall knowingly lie in an official report, statement, hearing, investigation, or command review.

Law 6. No Unauthorized Absence

No member shall abandon a meeting, operation, assignment, or official duty without permission from command or proper notice.

Law 7. Proper Conduct in Uniform or Representation

Any member acting in the name of Team RAR shall conduct themselves with discipline, seriousness, and dignity.

Law 8. Confidentiality of Internal Affairs

No member shall leak, reveal, or spread restricted Team RAR matters, plans, votes, orders, records, or investigations without authorization.

Law 9. No Fighting or Disorderly Conduct

No member shall start fights, encourage chaos, or disturb the peace of a Team RAR gathering, event, operation, or command session.

Law 10. Duty to Report Serious Violations

Any member who becomes aware of theft, sabotage, violence, major misconduct, or betrayal against Team RAR shall report it to officers or leadership.

Law 11. Respect for Rank and Office

Members shall recognize the authority of officers, commanders, chairpersons, and any lawfully appointed leaders of Team RAR.

Law 12. No Abuse of Team Power

No member may use Team RAR status, name, or authority for personal revenge, intimidation, unlawful gain, or improper control over others.

Law 13. Attendance and Participation

Members are expected to attend required meetings, activities, operations, and votes unless excused by leadership.

Law 14. Preservation of Order

Every member has a duty to help maintain order, discipline, and stability within Team RAR.

Law 15. No Theft or Misappropriation

No member shall steal, hide, misuse, or wrongfully claim team property, funds, supplies, or records.

Law 16. Proper Speech Before Command

Any member addressing command, officers, or official meetings shall do so respectfully and without disruption.

Law 17. Compliance During Investigations

Any member under review or questioned in an internal Team RAR matter shall comply with lawful internal procedure and command direction.

Law 18. No False Accusations

No member shall knowingly make false claims or accusations against another member, officer, or leader.

Law 19. Duty of Honor

Each member shall act with honor, discipline, and seriousness so as not to bring disgrace upon Team RAR.

Law 20. Acceptance of Discipline

All members, by joining Team RAR, agree to be subject to warning, probation, suspension, removal of privilege, removal of rank, or expulsion for violations of Team RAR law.

Law 21. Emergency Obedience Rule

During a declared emergency, all members shall follow emergency orders issued by Team RAR officers or command without delay unless relieved by higher authority.

Law 22. Chain of Command Rule

No member shall bypass the chain of command in official matters except in cases involving urgent misconduct, danger, or corruption requiring higher review.

Law 23. Conduct Unbecoming a Member

Any action that disgraces Team RAR, undermines its authority, weakens its unity, or damages its reputation may be punished as conduct unbecoming.

Law 24. Final Authority Clause

All members acknowledge that final interpretation of Team RAR law rests with the designated command authority, council, board, or governing leadership.

Closing Provision

By membership in Team RAR, each member accepts these laws as binding rules of order, conduct, loyalty, and discipline.
