#### CLUBHOUSE RULES

1. Out of respect for our fallen Comrades, **no** head dress of any kind is to be worn in the Club Room during open hours, unless engaging in theatrical / musical performance or for religious or medical reasons. The Sgt-at-Arms while on duty is exempt from this rule.
2. Profanity, abusive, derogatory or inflammatory language of any kind including that of a sexual nature will **not** be tolerated in the Branch at any time. Anyone using such language will be asked to leave the Branch by the Bar Steward or the senior Executive Member present. Political or religious conversations are discouraged.
3. The use of tobacco, tobacco products, marijuana or other drugs within Branch premises will **not** be tolerated. Anyone using such products will be asked to leave the Branch by the Bar Steward or the senior Executive Member present. Smoking is only permitted in designated outdoor areas.
4. Clubhouse privileges shall extend to all Branch Members and the public excepting those who are still under suspension.
5. Animals are **not** permitted inside the Branch premises except for service animals.
6. Members and guests are to return their empty bottles or glasses – bottles to beer cases and glasses to the bar
7. During open hours, the Bar Steward is responsible for the operation of the bar. The areas behind the bars are out of bounds to all members and guests except for the Executive Committee and volunteers in the course of their duties.
8. All patrons must vacate the premises within forty-five (45) minutes after “last call”.
9. Unruly or intoxicated person(s) will **not** be served by the bar and will be asked to leave the Branch premises and if so directed, will do so immediately.
10. **No** person(s) shall attempt to purchase an alcoholic beverage from the bar for an intoxicated person's consumption. Any person attempting to do so or found to have done so, will be denied further service and will be asked to leave the premises and will be expected to do so immediately.
11. Where a person has been identified for any type of misconduct and it is found that another member has been instigating said misconduct, the instigator will also be identified.
12. Persons playing indoor Branch Sports are responsible for any damage to or loss of Branch equipment used in the sport. The Branch will expect compensation for the damage in the form of cash.
13. All materials posted to the bulletin boards must be dated and approved and initialled by an Executive Committee member.
14. Televisions are for the benefit of members of the Branch. The volume setting and the channel selections shall be done by the Bar Steward at the request of a member based on a consensus of those members in attendance.
15. Minors must be accompanied into the Branch as guests by a parent or guardian of the minor. Parents or guardians shall **not** leave minors unattended.
16. Parking on Branch property is restricted to members, guest and visitors who are in attendance at the Branch. All other vehicles are subject to a ticket and/or towing at the owner's expense. **No** parking in fire lanes permitted. Branch is **not** responsible for any damage or loss to vehicles on Branch Property. Staff shall park in designated spaces.
17. Branch does **not** assume any responsibility for personal or unattended items. Found items may be stored in the Branch office for recovery.
18. Gang colours or patches is **not** permitted in the Branch events or on Branch premises.
20. No alcohol from outside sources are to be brought into these premises and no alcohol is to be removed from these premises unless under a special event liquor license.
21. In any instance that a person(s) is asked to leave the Branch for any reason and fails to do so immediately, Police may be called.
