

# TAKE CONTROL OF YOUR HEALTH RECORDS!

## My Health Records PCP - How It Works

1. Your records are spread across every password protected portal of every provider, facility or service you have ever used.
2. Our AI data partner goes into every Electronic Medical Records system (EMR) of any and all of your providers, insurance company databases, Health Information Exchanges (HIEs), etc. to bring that data home to YOU in one place.
3. That AI process removes duplicate information, ranks the priority of your medical diagnoses, and then summarizes the data for easy access.
4. YOUR data is only accessible to you and updates in real time on your MHR-PCP patient portal.
5. If you were treated in 10 facilities in 10 states those individual records will find their way home to your portal.
6. You can now print or transfer this data into any EMR system.

## My Health Records PCP - Programs & Pricing

1. In our environment where even those with health insurance may not feel that they can afford to use it, health access options that take cash or insurance are what's most needed.
2. Full access to own, store and transfer your records is \$9 per month if paid annually upfront or \$108.
3. The same program if paid monthly is \$12.50 or \$150 for the year.
4. Your MHR-PCP provider responsible for requesting and maintaining your access to records in our portal must be registered with us.
5. This can be your PCP, or one of our registered PCPs.
6. For compliance purposes and to maintain this relationship, and thus your access, you are required to have two virtual visits per year even if you use your own provider.
7. If you choose to use our registered PCPs and pay the year in advance, that total cost for both visits is \$120, or \$60 per visit.
8. If you pay by the visit, you will pay \$75 each time or \$150 for the year.
9. We can introduce you to a monthly unlimited virtual care subscription, also for less than any TV streaming service. They have family plans too!
10. We can also connect you to labs, imaging, specialists, etc. using your insurance or cash pay between you and that service.
11. For only \$1 per month, you and your family can add access and explore over 700 medical assessments, calculators and algorithms.
12. There will be an entire a la carte section for any and every group purchasing health access products and services that you could imagine.
