This Pet Sitting Service Agreement (“Agreement”) is entered into by and between:

For the purposes of this Agreement, the terms “Client” and “Pet Owner” are synonymous with the person contracting services for one or more domestic animals. “2 Dogs Pet Services, LLC” refers to the pet care company providing pet sitting services.

Services & Pricing

In-Home Pet Sitting

- Up to \$90 per night for up to 2 pets
- \$25 per additional pet per night

Drop-In Visits

- \$30-\$35 per 30-minute visit

Boarding (at 2 Dogs Pet Services, LLC’s location)

- Up to \$90 per night for 1 dog
- \$25 per additional dog per night

Taxi Services

- \$25 per trip within 10 miles, plus \$.70 per mile over 10 miles.
- Anything over 50 miles will be at a negotiated rate.

Note: Prices include feeding, water, exercise, companionship, and routine care. Any additional services, such as medication administration or specialized care, may incur additional fees.

Liability Waiver

Injury to Client's Pet(s) by Another Animal

2 Dogs Pet Services and its contractors will take all reasonable precautions to prevent any injury to Client's pet(s). However, 2 Dogs Pet Services will not be held liable for injuries sustained in fights between Client's pet(s) and other animals unless gross negligence or intentional misconduct is proven.

Injury or Escape of Pet(s)

Client acknowledges that even with the highest level of care, pet(s) may become injured, lost, or escape. 2 Dogs Pet Services will not be held liable unless such an event is caused by gross negligence, recklessness, or intentional misconduct.

Injury to Pet Sitter or Others by Client's Pet(s)

Client is responsible for any injuries inflicted by their pet(s) on the pet sitter or any third party. The Client agrees to cover all medical expenses, legal fees, and damages resulting from such incidents.

Unsafe or Aggressive Pet(s)

If a pet becomes unmanageable or aggressive, 2 Dogs Pet Services reserves the right to terminate services immediately. No refunds will be given if services are terminated due to a pet's behavior.

Off-Leash Play & Outdoor Access

Some Clients request off-leash exercise for their pet(s). If permitted, Client acknowledges that injuries, escapes, or incidents may occur, and 2 Dogs Pet Services will not be held liable.

- Client must initial to approve or decline off-leash play:
- I do NOT want my dog(s) to be off-leash at any point during pet sitting or dog walking services. (____ Initials)

Veterinary Release Agreement

In the event of illness or injury, 2 Dogs Pet Services will make reasonable efforts to contact the Client immediately. If the Client cannot be reached, 2 Dogs Pet Services is authorized to seek veterinary treatment for the pet(s) at the Client's designated veterinarian or, if unavailable, at the nearest veterinary clinic.

Client agrees to assume full financial responsibility for any veterinary expenses incurred on behalf of their pet(s). If veterinary care is required, the Client will reimburse 2 Dogs Pet Services for any costs paid upfront.

Payment & Cancellation Policies

Payment Policy

- A 50% deposit is required at the time of booking to hold pet sitting dates.
- The remaining balance is due 24 hours before or on the day of the Client's departure.
- Accepted payment methods: Venmo, CashApp, check, or cash.

Cancellation Policy

Non-Holiday Cancellations

- 8+ days' notice: Full refund.
- 4-7 days' notice: 50% refund (deposit forfeited).
- 3 or fewer days' notice: No refund; full payment required.

Holiday & Long-Term Reservations (14+ days)

- 15+ days' notice: Full refund.
- 7-14 days' notice: 50% refund (deposit forfeited).
- 6 or fewer days' notice: No refund; full payment required.

Early Return or Late Departure

No refunds will be issued for early returns. Clients returning after 8:00 PM will be charged an additional night of service.

Last-Minute Booking Fee

A \$35 fee applies to bookings made within 72 hours of the requested service start date.

Dog Walking Cancellation Policy

Regular monthly dog walking Clients must provide two (2) weeks' notice to discontinue service. If notice is not given, the Client agrees to pay for two weeks of service.

Key Release & Home Access

Client agrees to provide 2 Dogs Pet Services, LLC access to their home through keys and/or access codes for the duration of pet sitting services.

Additional Household & Home Security Terms

• Third Parties in the Home:

For our protection (and comfort), we no longer allow additional people to be present in the home during overnight dog sitting or drop-in visits. This does not include cleaners or contractors, with approval by Pamela Key or Victor Debitly.

• Plant Care: Reasonable plant care is available upon request, but we are not responsible for wilted, dead, or otherwise unhealthy plants.

• Trash Curb Service & Mailbox Check: Both services are included at no additional charge.

• Home Repairs & Damage: 2 Dogs Pet Services, LLC is not responsible for leaks, electrical failures, or damage due to acts of nature. Client agrees to reimburse the company for any expenses incurred due to unexpected home maintenance emergencies.

• Burglary & Security: 2 Dogs Pet Services, LLC is not responsible for any loss or damage due to burglary. Client agrees to secure their home before departure.

As a convenience and to aid in communication, we do request access to internet services while caring for the pets.
