

## Fee Schedule North Coast Kids Academic Preschool 2026-27

### Deposit / Supply Fee (Non-Refundable)

Due at time of Registration to Secure Spot

2 Day Program ..... \$125

3 & 4 Day Program ..... \$150

Deposit/Supply Fees are non-refundable. A student's spot is not secured until this fee is paid in full.

---

### Monthly Tuition (September–June)

#### Preschool Prep

2 Day Program | 9:00–12:00 PM ..... \$306.50/month

#### Preschool

3 Day Program | 9:00–12:00 PM ..... \$411.20/month

#### Pre-K

4 Day Program | 9:00–1:00 PM ..... \$684.00/month

5th Day Add-On (Fridays 9:00–1:00 PM) ..... \$150/month

Tuition is a yearly fee divided into equal monthly payments from September through June.

Tuition is not prorated for absences, illness, holidays, school breaks, weather-related closures, emergency closures, or partial months of attendance.

Tuition may not be withheld or deducted for any reason.

### Family Registration Fee

Due per Family, charged annually on September 1st ..... \$40

This fee is non-refundable.

---

### Field Trip Fees

Due at time of Field Trip Booking (yearly fee) ..... \$20–30/year

Field trip fees are non-refundable once booked.

---

### Afternoon Enrichment (Billed Monthly)

Preschool Add-On | M/W/F | 12:00–2:00 PM ..... \$199/month

Pre-K Add-On | M/T/W/TH | 1:00–2:00 PM ..... \$119/month

Enrichment may be added month-to-month. A 30-day written (emailed) notice is required to discontinue enrichment.

---

### Billing

Families receive email statements on the 25th of each month for the following month.

Tuition is automatically charged on the 1st of each month from September through June.

By enrolling, families authorize the school to automatically charge the payment method on file for tuition and applicable fees.

It is the family's responsibility to ensure that the payment method on file is valid, current, and able to process tuition charges.

### **Late Payments:**

If tuition is not successfully processed by the 5th of the month, a \$25 late fee will be applied. Failed payments due to expired cards, insufficient funds, banking errors, or processing issues are still considered late payments and remain the responsibility of the family. Accounts more than 30 days past due may result in suspension of services until the account is brought current.

---

### **Non-Sufficient Funds (NSF)**

NSF fees are non-removable and must be paid in full. Any NSF fees incurred, including bank fees, processing fees, or related charges, are the responsibility of the family.

---

### **Registration**

The Deposit/Supply Fee is required to secure your student's place. These fees are non-refundable. Until fees are paid, your student's spot is not secured.

Parent or Guardian information must be entered into iClass. Only parents or guardians listed in iClass may pick up or drop off a student or receive information regarding enrollment or attendance.

---

### **Withdrawal**

If a family withdraws during the school year, a 30-day written (emailed) notice is required.

The 30-day notice period begins on the date written notice is received and may not be applied retroactively.

Upon early withdrawal, families are responsible for tuition for the current month and the following month, regardless of the student's last day of attendance.

No refunds will be issued.

---

### **School Closure / Forced Closures**

In the event of closure due to government order, natural disaster, public health emergency, or circumstances beyond the school's control, tuition policies may be modified at the school's discretion.

---

### **Policy Changes**

The school reserves the right to modify tuition rates, fees, or policies with written notice.
