2024 Board of County Commissioner Candidates for District 1

Ouestions were given to all candidates on May 18, 2024. All candidates were asked to respond no later than June 1, 2024. This document was produced June 14, 2024.

1. What is your background?

2. Why are you running for this position now?

I have always enjoyed watching politics and worked with Rep. Adam H. Putnam as his staff assistant after graduating from Florida Southern College worked as the Public Affairs Director for the Lakeland Area Chamber of Commerce, where much of my position was administering the Government Affairs Committee, Business Voice, Inc, and also was heavily involved in the County-wide campaign to change the Superintendent of the Polk County School Board to go from an elected position to an appointive system. 4. What do you believe are the most important (not necessarily urgent) challenges/priorities facing Polk County and the Board of County Commissioners (BoCC)?

Henry Coker



Intelligent growth management with an focus on planning and implementing impactful infrastructure for the projected increases in the population over the next 25-50 years.

Kay Klymko



An important priority is that residential and commercial growth is in balance with supportive infrastructure and strategically placed to minimize environmental impacts. We must ensure clean potable water for now and in the future with a strong Polk County Regional Water Cooperative and knowledgeable commissioner liaison. Our strategic growth plans must preserve our upper Floridan aquifer and Lake Wales ridge recharge and scientific best evidence used in the experimental wells constructed to reach the deep Floridan aquifer.

Building our health care services to better meet the needs of the rapidly growing older adult population (50 years +) who comprise almost 40% of Polk County is a challenge. People want supportive home health care services at a reasonable cost that will permit our residents to stay in their homes as long as possible.

Planning for affordable housing availability is a priority that is safe with first responders prepared to practice just surveillance and rapidly respond to crisis situations within a reasonable period.

Judi New



Important challenges facing Polk County include balancing the opportunities that have resulted from massive growth due, in part, to business and developer-friendly policies approved by the Commission with the reality that our current Commission has continued to neglect the proper funding of our public infrastructure. It is their duty to balance this through careful, measured, and managed policies. We really need to see our roadways as a safety issue, especially with our County growing to 1 million people by 2030. We need to work hard now to make changes that will help future generations love Polk County for its uniqueness and beauty. I want my children to want to live here one day and not move somewhere that is easier to navigate. This is my mantra: "A society is made greater when people decide to plant trees in the shade that they know they will never sit."

Jennifer Price



1. Elevate development standards to prioritize the well-being and individual property rights of citizens and local businesses.

2. Accelerate the development of an infrastructure plan that alleviates immediate needs while simultaneously planning for the future. 3. Develop strategic ways to attract a range of businesses to our county to promote business diversity and champion the growth of small businesses. 4. Create comprehensive solutions to attract and retain dedicated first responders, to ensure we retain our finest and not lose qualified and experienced team members to neighboring counties. 5. Preserve and maintain Polk's natural resources such as clean water, green areas, and wildlife habitats.

5. Given Polk's recent record-breaking growth, what plan and what timeline should the BoCC follow in terms of impact fees and curbing growth in a way to allow planning experts to aid in distribution and placement of homes, citizens, and county facilities?

Henry Coker



Planning needs to begin now if not already in motion. Priorities, time lines and funding strategies need to align and grow with the expected needs.

Kay Klymko



Polk County applies impact fees received from developers to support related infrastructure needs with categories of Emergency Management Services, Transportation, Correctional facilities, Educational, Library, Parks and Recreational, Fire Rescue, and Law Enforcement infrastructure. Impact fee adjustments must be in accordance with the Florida Impact Fee Act (cited 163.31801; 2023 Florida Statutes) which has specific requirements such as the calculation of impact fee needs to be based on the most recent and localized data and fees may not be increased more than once in four years. As an example of these timelines, the PCBC raised new transportation impact fees for Polk County effective 07-01-23 with fees phased in annually over several years. For the category of a single family detached unit (per dwelling) located in Zone B (North-West Polk County), fees in phase one (2023) would be \$2,649, in phase two (2024) would be \$2,918, and in phase 3 (2025) would be \$3,187. Polk County's fee in this example would reach the median impact fee (\$2,764.50) of other Florida counties by the second year of its increase (Braverman, Samuel P., Florida County Impact Fee Study, January 2022). Using this example of timeline for impact fees adjustment, my approach would be to support an additional impact fee increase after 2027 when legally permissible and provided recent and localized data is supportive.

Judi New



Demand to live in the County has never been higher; however, the path that both the Planning Commission and the Board of County Commissioners have approved to supply that demand has been mismanaged. I believe this stems from a failed comprehensive infrastructure, utility, and public spaces plan with adequate public and private funding mechanisms. Planning experts are only effective when the Commission has a strong backbone to listen to the recommendations and properly weigh the costs and benefits to make the hard decisions. Moratoriums just buy time and are only a temporary bandage, which creates additional problems. Impact fees should actually be impactful to our future growth and not squandered or utilized in attempting to fix the sins of the past. The bigger issue is that Polk now has upwards of \$3 billion of unfunded transportation improvements, and with The Board of County Commissioners updating the County's Comprehensive Plan this year and I intend to be a part of the discussion on behalf of my future constituents to make sure that Polk County is the strong, beautiful, growing and wonderful place that we call home.

Jennifer Price



Horizontal development needs to be in place to support the growing community before vertical development takes place while we stabilize. Those driving sprawling residential growth should proportionally contribute to further infrastructure development. While unpopular with developers, impact fees should be increased at a consistent rate over the next few years to provide for the actual impact. Traffic congestion and accidents are a source of woe for nearly all residents, while our first responders are consistently working double shifts to accommodate this unrestrained growth. Planning experts should be from the area and familiar with the concerns/patterns rather than trying to convert Polk County into a larger municipality like Tampa or Orlando.

6. How can municipalities and city governments within Polk County work more effectively with the County Commission, and what are the best steps citizens can take to have their voices and concerns heard by the BoCC?

Look at current trends and needs assessments, growth indicators and projections. Town Halls for community input. A planning board with membership representatives from all government sectors and the community at large.

Kay Klymko



Polk county has multiple incorporated municipalities, and unincorporated populated areas with Lakeland the largest city. The example of the Polk County Regional Water Cooperative with representatives from municipalities and a representative from the PCBC as formed surrounding a major issue can serve as the best example of how citizens may organize to have issues addressed. The PCBC can continue to facilitate this type of organizing of municipalities with more inclusion of other populated areas to assure county-wide inclusiveness.

Judi New



After driving over 13,000 miles around our County, I have been introduced to each municipality and I am building relationships with most of the City Managers and City Staff. Everyone I meet is incredibly good at what they do in their public service role, but they are looking for the County to set effective policy and stick to it. That requires input from our public servants and our citizens. One way that I believe citizens can have their voices heard is through social media. Through campaigning, social media has been an excellent way of communicating with people and I think this is the way of the future for citizens to interact with the Commissioners. It is so easy to message, email, and call.

Jennifer Price



We need to open the conduit for clear communication with municipalities and city governments. I want to shift at least one County Commission meeting per month to be held in the evening to afford those who work daytime hours to attend without having to take time off. I also feel strongly we need public communication that is in line with current technology of 2024. While a public notice in the newspaper is considered sufficient, social media must be leveraged as means to communicate and interact with our constituents. I would also push for regular town hall meetings for voters to meet with their elected officials.
