2024 Board of County Commissioner Candidates for District 5

Questions were given to all candidates on May 18, 2024. All candidates were asked to respond no later than June 1, 2024. This document was produced June 14, 2024.

1. What is your background?

If elected, I would aggressively seek to modify the development guidelines to promote smart growth that would encourage infill and provide adequate emergency services for the increased population.

Ricky Shirah



Growth management, infrastructure improvements, affordable housing, good high-paying jobs and good roads for any future growth. Bring Brightline to Polk County for rail between Orlando and Tamps with stops in Polk County.

5. Given Polk's recent record-breaking growth, what plan and what timeline should the BoCC follow in terms of impact fees and curbing growth in a way to allow planning experts to aid in distribution and placement of homes, citizens, and county facilities?

John Hall



Polk County hires professionals periodically to perform impact fee studies to insure that our impact fees are in line with current market impact fees. The County has a professional planning staff that reviews all development submittals to make sure they comply with the Land Development Code and the Polk County Comprehensive Plan.

Mike Scott



If elected, I can make a difference by imparting my technical expertise as a civil engineer and business owner to correct the current trajectory of overgrowth in some areas that lack the necessary infrastructure to support the new population. Transportation impact fees are already set to increase on July 1, 2024 and July 1, 2025. Impact fees are not the only, or in some cases the best, tool to use in curbing growth. I will opine on best options after a more comprehensive review of the existing plans in place and staff input.

Ricky Shirah



Given Polk County's unprecedented growth, the PCBC faces a critical juncture requiring a strategi plan to manage development while ensuring sustainable and equitable growth. This plan must prioritize a comprehensive approach that balances economic prosperity with responsible land use. In terms of impact fees, the PCBC should implement atirered system increasing fees based on the intensity of development and the demands placed on infrastructure. This would encourage developers to prioritize projects that minimize strain on existing services and allow for targeted investments in infrastructure improvements. Additionally, the PCBC should establish a clear timeline for implementing these fee changes, providing developers with adequate notice and opportunity to adapt. To curb growth, the PCBC should consider adopting a phased development approach, allowing for controlled growth in specific areas while preserving sensitive ecosystems and natural resources. This approach would require the PCBC to engage with planning experts to identify optimal locations for future development, prioritizing areas with existing infrastructure and minimizing environmental impact. This strategic placement of homes and facilities would foster a more balanced distribution of residents and services, mitigating the strain on existing communities. Lastly, the PCBC should prioritize public engagement and transparency throughout this process. Regular public forums and online platforms would provide citizens with opportunities to voice their concerns and participate in shaping the county's future. By fostering collaboration between stakeholders, the PCBC can ensure that growth in Polk County is managed sustainably, equitably, and in a manner that benefits all residents.



6. How can municipalities and city governments within Polk County work more effectively with the County Commission, and what are the best steps citizens can take to have their voices and concerns heard by the BoCC?
