Questions were given to all candidates on May 18, 2024. All candidates were asked to respond no later than June 1, 2024. This document was produced June 14, 2024.

The biggest issue related to election administration is maintaining confidence in the integrity of our elections. I will address this by continuing to conduct fair and secure elections in a transparent manner. I will continue to build partnerships and invite community members to observe and participate in our elections. As more people observe and learn how our elections are run we will continue to see trust and confidence grow.

As your Supervisor of Elections, I will be focused on educating Polk County about our right to vote. I have always said that if we can get education right, we can get the world right and that applies to our elections as well. It is important to have a well-educated constituency and as your Supervisor of Elections it will be my focus to educate the citizens of Polk County about their sacred right to vote. When I am your Supervisor of Elections, I will ensure that voters throughout all of Polk County are provided with the opportunity to register to vote.

#### **Lori Edwards**



We have a very active outreach and community education program, visiting more than 200 events every year. The overriding rule is to ensure fairness. This is accomplished by mapping our visits to ensure that we visit all geographic areas of the county and working to expand our community contacts. Additionally, we visit all Polk high schools every year to offer young people the opportunity to learn about elections and offering them the opportunity to register to vote.

6. Some national commentators (both conservative and liberal) have suggested that voting systems can be hacked or will be hacked in November. How will you as the leader of the office ensure that elections in Polk are free and fair, and how much influence does the Polk Supervisor of Elections have in setting Florida policies and procedures?

# **Melony Bell**



To start, I will ensure that we follow the rules and laws set by the legislature and by the Supreme Court of the State of Florida. As your Supervisor of Elections, I will ensure that we have an independent auditing process in place. Furthermore, I will make sure all voter rolls are cleaned up in a timely manner, per Florida Statute. I will pay close attention to proposed changes to our election laws and ensure that these measures strive for fair and free elections.

#### **Lori Edwards**



In addition to using only election tabulation equipment that has been rigorously tested and certified by the Florida Department of State, we employ multiple layers of physical security and chain of custody procedures. Each voting machine is tested for accuracy each election before being deployed. A manual recount audit is performed after each election on randomly selected precincts. All ballots are accounted for by balancing votes cast against Polk voters who signed the register or certificate envelope. Florida law and rules promulgated by the Florida Division of Elections provide the framework and we add and customize procedures to ensure election integrity.
