#### **Brandon Alvarado**





# 6. There are individuals being served by Lake Wales utilities that do not live inside the city limits. Would you support a Lake Wales commission seat being designated for those individuals' representation?

I believe every resident of a city should be represented. This is no different than my belief about every citizen of our country having a voice by their vote. The city of Lake Wales is growing quickly. The areas that have not had a representative in the past now have enough people residing in them to warrant a representative. There are revenue generating opportunities in these areas. The ordinances of the city do affect these groups outside city limits. The traffic alone has impacted their roads, which have lacked proper maintenance.

# 7. Our neighborhood is marked No Soliciting. What can be done about the daily knocks on our doors by Solar, Roofing and Window Replacement representatives.

While it can be frustrating, solicitors are protected through their right of free speech for commercial purposes. Posting "No Trespassing" or "No Soliciting" signs might also help deter potential solicitors.

I have had the "privilege" of being solicited for services I neither wanted nor needed. It is annoying and interrupts my day. The fact that these people ignore the posted signs should speak to the lack of them being held accountable for their actions. I would like the city to designate the duty to an existing department to receive complaints from homeowners and businesses and then have the city fine the businesses in violation of soliciting where there are clear posted signs stating, "No soliciting". There should be a phone number distributed to city residents so that they are aware of who they can contact when solicitation occurs. There should also be a posted description of what soliciting is and the activities it encompasses in areas the solicitation is prohibited. There are some people who are ignorant of the fact that they are soliciting, and this type of sign would help. I believe that clear communication and holding the solicitors accountable is the key to stopping their behavior.

Solicitors can be prohibited from knocking on your door if you post a no soliciting or no trespassing sign on your individual private property; please check with your HOA to see if you are allowed to post signs.

## **Brandon Alvarado**




