AN ORDER UPON THE GOVERNMENT OF THE STATE OF TENNESSEE TO RESTORE THE REPUBLICAN FORM OF GOVERNMENT ESTABLISHED IN THE CONSTITUTION OF THE STATE OF TENNESSEE

WHEREAS, Article IV, Section 4 of the Constitution of the United States guarantees to every state in this union a republican form of government; and

WHEREAS, ON _____, 2025, I, President Donald J Trump received an Article IV, Section 4 Guaranty Demand from Mr. John A Gentry, a citizen of the United States and the State of Tennessee, protesting that the State of Tennessee has forsaken its republican character and form; and

WHEREAS, review of the material and evidence provided to the Office of the President of the United States by Mr. John A Gentry, evidences in fact and without question that the government of the State of Tennessee has forsaken its republican character and form; and

WHEREAS, it is the duty and within the Executive Powers vested in the President of the United States to enforce Article IV, Section 4.

NOW THEREFORE, I Donald J Trump, President of the United States, by virtue of the power and authority vested in me by the Constitution of the United States, do hereby direct and order the following;

1. The Tennessee House of Representatives and Tennessee Senate shall uphold and cease oppression of the rights of its citizens protected in Article I, § 23 of the Constitution of the State of Tennessee, and particularly the right of citizens to apply to the Tennessee House and Senate for redress of grievances or other proper purposes by oral address.
2. The Tennessee House of Representatives and Tennessee Senate must welcome Mr. John A Gentry to orally present his application, filed with the Clerk of the Tennessee House of Representatives on May 3, 2021 to a quorum of the House and Senate. See attached letter from state Representative Garrett, and Mr. Gentry's Art. I, § 23 application.
3. The Tennessee Board of Judicial Conduct must be abolished, and all present and future complaints of judicial misconduct must be directed to the Tennessee House of Representatives for consideration.
4. The Tennessee Code Commission must be abolished or reconstituted with members not prohibited by the Constitution of the State of Tennessee, and authority to edit, or propose revisions to public acts of the General Assembly, and submit bills to the General Assembly be rescinded.
5. Proposed amendments to the Constitution of the State of Tennessee must be properly published to the people of the State of Tennessee, circulated, and made known to the people in general, with copies distributed to the public, in compliance with Article XI, Section 3 of the Constitution of the State of Tennessee.
6. The Board of Professional Responsibility must be abolished. The legislature may establish an agency to oversee the licensure and conduct of attorneys, but such agency must be separate from the judicial department of the state, and attorneys facing potential disciplinary action must be provided due process and trial by jury when not waived.

FURTHERMORE, if the government of the state of Tennessee fails to timely comply with this Executive Order, federal enforcement for which execution will issue if necessary, and will commence, including by not limited to; withholding of federal monies, federal appointment of a military governor, dissolution of the Tennessee General Assembly, and federal appointment of circuit, chancery, general session, juvenile, and appellate court judges and supreme court justices to Tennessee courts.
