1. Geneva, Switzerland

Region: Rue du Rhône and Quai du Général-Guisan, the heart of watchmaking, these arteries extend from boutiques to flagship stores. The nearby Patek Philippe Museum is an ideal stop for examining historical pieces.

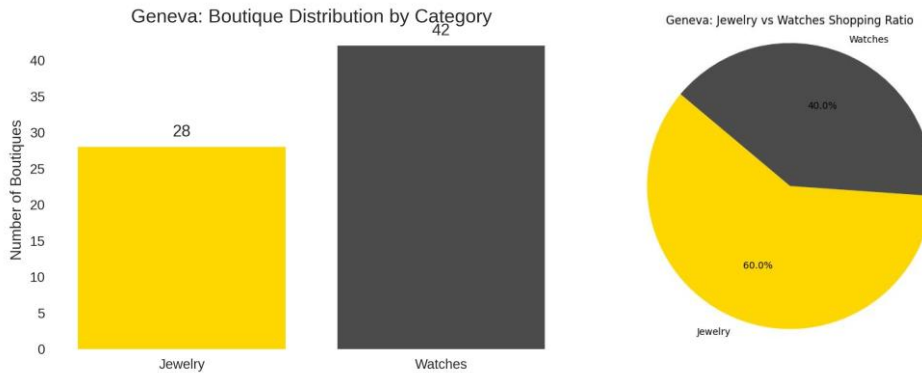
Brands: Patek Philippe, Vacheron Constantin, Audemars Piguet; additionally Rolex and Omega icons offer exclusive limited editions.

- **Payment Methods:** Credit cards (Visa/Mastercard), debit cards and cash (CHF/EUR) are widespread; Apple Pay and Google Pay are supported. For high-value purchases, escrow accounts are recommended.
- **Money Transfer:** SWIFT-based bank transfers (via UBS, Credit Suisse or Julius Baer) are quick (1-2 days); fintech options like Wise offer low-fee alternatives.
- **Customs and Export:** Tax exemption up to CHF 150 for personal use; export declaration mandatory for high-value jewelry (via Swiss Customs). Zero customs duty advantage for non-EU investors.
- **Security and Other:** High-security boutiques (24/7 CCTV, private vaults); English is common with free concierge services. Language barrier low; mix of French/English.



2. Paris, France

Region: Place Vendôme and Rue Saint-Honoré, the epicenter of haute couture; the Vendôme area integrates historic hotels with boutiques.

Brands: Cartier, Boucheron, Van Cleef & Arpels; additionally Chaumet and Buccellati stand out with exclusive haute joaillerie pieces.

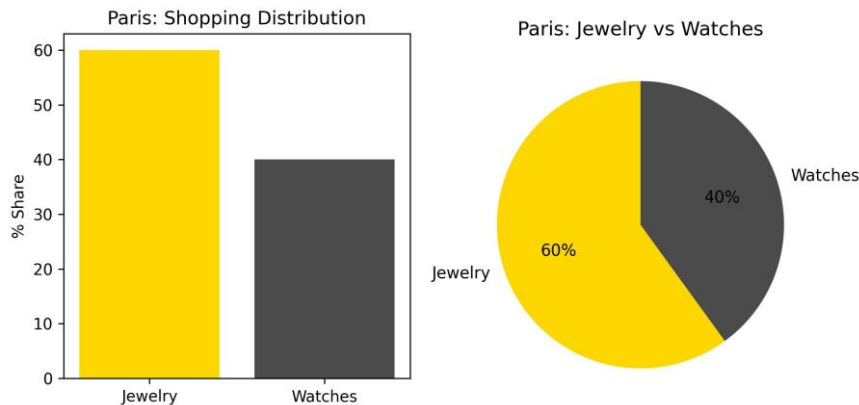

3. Milan, Italy

Region: Via Montenapoleone and Galleria Vittorio Emanuele II, the heart of fashion week; the Galleria offers shopping within an architectural masterpiece.

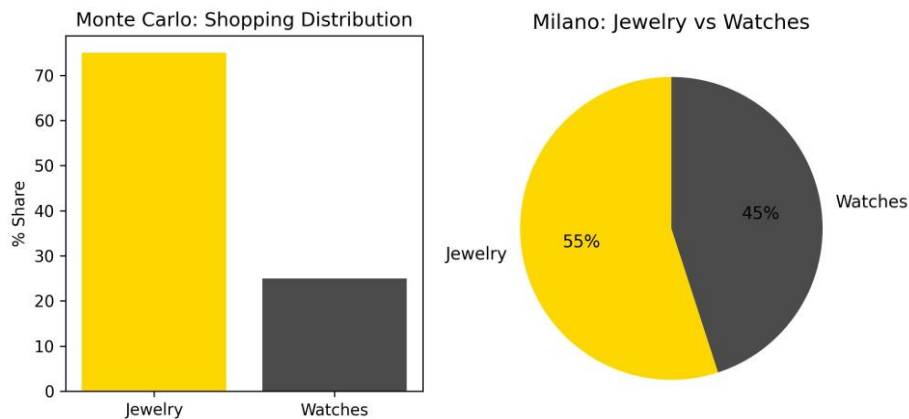
Brands: Bulgari, Pomellato, Panerai; additionally Piaget and Chopard produce fusion pieces with Italian craftsmanship.

4. Dubai, UAE

Region: Dubai Mall and Gold Souk, a massive luxury ecosystem; the Souk provides a traditional market contrast.

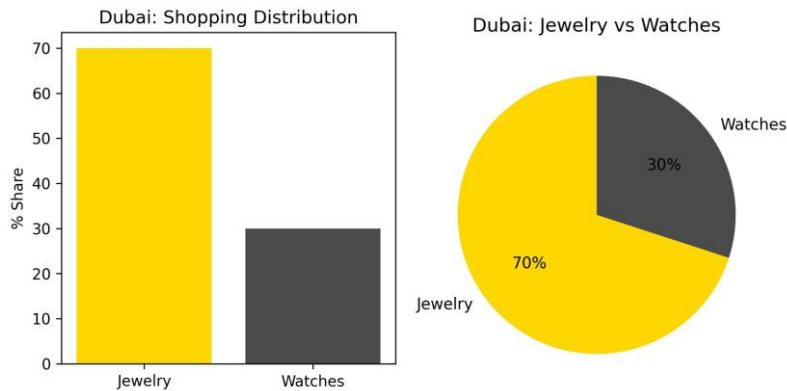
Brands: Graff, Chopard, Rolex; additionally Damas and Al Fardan offer fusions with Arab design.

5. New York, USA

Region: Fifth Avenue and Madison Avenue, a luxury corridor amid skyscrapers; proximity to Rockefeller Center adds convenience.

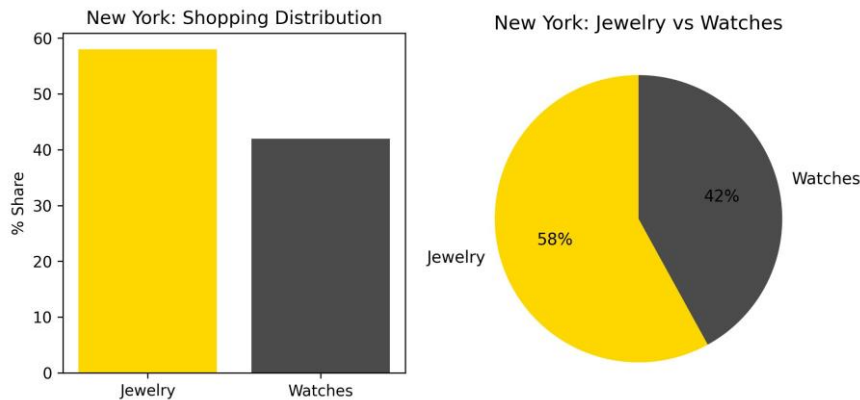
Brands: Harry Winston, Tiffany & Co., Jacob & Co.; additionally David Yurman and Verdura with American innovation.

Paris and Milan cater to cultural prestige seekers despite higher taxes and Hong Kong emerges as a tax-free powerhouse for East Asian trading, complementing Shanghai's scale. New York and Beverly Hills offer American dynamism—East for classics, West for celebrity flair—but lack refunds. London and Monte Carlo provide elite heritage with the latter's niche yacht ties. Tokyo leads in tech elegance, Seoul in value-driven innovation, ideal for younger HNWI's.

Risks: Geopolitics (Hong Kong/Shanghai), currency (Tokyo/Seoul), logistics (Los Angeles).

Future trend: Digital ownership and sustainability will standardize, boosting resale across all. For optimal returns, pair Geneva-Hong Kong for 18%+ annual appreciation in watches and gems.
