# Terms and Conditions

## 1. Registration

- 1.1.** The Breeder certifies that this puppy was bred in accordance with the AKC registration requirement for purebred dogs.
- 1.2.** The Breeder has applied to the AKC for Litter Registration and individual papers for your Puppy will be issued directly to you or supplied with the Puppy if already obtained. Papers will be provided within 45 days of sale (dependent upon AKC processing times).
- 1.3.** The Buyer agrees that if, at any time during the life of the Puppy, you are unable to keep the Puppy then ownership of the Puppy reverts to the Breeder AT NO COST and the Breeder will make the necessary arrangements to find a suitable new home.

## 2. Full Registration

- 2.1.** The Puppy is being sold on Full Registration.
- 2.2.** Under Full Registration the Puppy is able to compete in Obedience, Agility and the Conformation Show Ring.
- 2.3.** Under Full Registration the Puppy is able to have offspring registered with the AKC or any other relevant State/Territory body providing other requirements as a Breeder are met.
- 2.4.** The Buyer agrees to DNA report and minimum health checks to include patellar luxation and cardiac, and have satisfactory outcomes prior to breeding.
- 2.5.** The Buyer agrees to provide show results to the Breeder.

## 3. Health Guarantee

- 3.1.** The Breeder certifies that the Puppy is, to the best of their knowledge, healthy at the time of sale.
- 3.2.** The Breeder certifies that both parents have been Health Tested (minimum patellar luxation, cardiac) prior to breeding and copies of the tests results are provided to the Buyer. Any abnormal test results were fully disclosed and discussed prior to purchase and every effort has been made to ensure the Puppy is healthy, socialized and well raised prior to sale.
- 3.3.** The Breeder will provide vaccination, health background and worming details to the Buyer.
- 3.4.** Within 7 Days of Sale: If the Buyer changes their mind or circumstances change, the Puppy (including all documents, medication, food and other materials provided by the Breeder) may be returned to the Breeder for 50% refund.
- 3.5.** Within 1 year of Sale: If the Puppy is determined to have a major health defect, the Puppy may be returned to the Breeder for a Full Refund (100%). All documentation, including vet notes and tests to be provided to seller. Seller retains right to have diagnosis verified by vet of her choice. This refund policy does NOT cover death due to neglect, abuse or misadventure.

## 4. Additional Provisions

- 4.1.** The Buyer agrees to provide for the Puppy's emotional and physical care, including nutritious food and annual physical examination.
- 4.2.** The Buyer agrees to house the Puppy indoors the majority of time. When outdoors the Puppy will require fixed shade, ample safe and clean water supply and complete and secure fencing.

**4.3.** Should the Buyer be unwilling or unable to fulfill any of the above provisions, or if any local authority seizes the dog as being neglected or abandoned, the Breeder retains the right to reclaim the Puppy without compensation.

**4.4.** The Buyer agrees to pay the Breeder any and all expenses, including court costs and reasonable Attorney fees in enforcing the terms and provisions of the Contract.

### **5. Deposit, Payment & Fees**

**5.1.** Buyer to pay a deposit of \$250.00 with payment of the balance of \$ due upon release of puppy to buyer. The expected delivery date is such as the puppy reaches safe weight to leave mother.

Payment of the balance \$\_\_\_\_ can be paid by cash, cashier check, money order or Zelle with no surcharge. Cash App/Venmo (no charge if marked as personal), PayPal (3.75% surcharge), and Credit Card (3% surcharge). \$150 discount if paid by cash.

**5.2.** Buyer acknowledges deposit is non-refundable but can be moved to another puppy or litter.

### **6. Indemnity and Release**

**6.1.** Buyer releases Seller from the liability, costs or damages caused by the Dog after placement with Seller, including but not limited to damage to or destruction of property, and injury to any person,

**6.2.** Any action or claim brought by Buyer against Seller for breach of this Agreement or for loss due to negligence must be brought within (1) year of the date such claim or loss occurs.
