Sunriver Fire Department is conducting a recruitment process to establish an eligibility list to fill future Reserve Firefighter/EMT positions.

Salary Range: \$12.00- \$14.00 per hour depending on qualifications

Open Period: Accepting continuous applications

Position Information: Part-time

Work Schedule: Members may work up to two 12-hour shifts from 0800-2000 during set workweek (Monday-Sunday)

Benefits: Sunriver Fire Department provides employees with benefits including, but not limited to, Public Employee Retirement (PERS), employee assistance program, Sick time, and training opportunities

Example of duties: Reserve Firefighter / EMT responsibilities include incident response, apparatus operation, report writing and fire ground operations.
