C. Pecunious Grammateus Report - Soror Kamela Fulbright presented the report. For the months of December, 2025 the chapter collected \$24,032.90. The Pecunious Grammateus Report will be filed for audit and placed online in the Members Only section of the TRO website.

D. Tamiouchos - Soror Vanessa Vavasseur presented the Tamiouchos report for the month of December, 2025: Operations account balance \$38,837.21; Program account balance \$47,247.28; Contingency account balance \$3,279.59. The Tamiouchos Report will be filed for audit and placed online in the Members Only section of the TRO website.

- As of January 2026, 81 sorors have paid 2026 dues.
- Below is status of the 2026 Operations Budget:
 - **2026 Approved Budget = \$21,851**
 - 85 sorors x \$257
 - 81 sorors x \$257 act = \$20,817
 - Budget shortage \$ 1,034 (\$21,851-\$20817)
- The Operations budget is also short due to 3 sorors 85 and over and electing to pay 10% less of \$257, per TRO Chapter Bylaws.
 - 2026 approved budget \$21,851
 - Shortage due to 4 sorors \$1,034
 - shortage due to 3 sorors \$77.10
 - Current paid Budget \$20,739.90
 - Total budget shortage \$ 1,111.10
