## **FUNCTIONS OF THE POSITION**

- Operates trucks of various sizes and weights in the loading, hauling, and unloading of various equipment, materials, and supplies.
- Operates trucks and construction or power equipment, such as backhoe, man-lift, dump truck, snowplow, road grader, front-end loader, track excavators, and/or skid steers.
- Operates multiple pieces of construction equipment used in underground construction, base preparation and construction, and/or paving.
- Operate all heavy equipment in a safe and appropriate manner.
- Perform daily maintenance and safety checks of equipment.
- Conduct pre-operational checks on equipment and clean, lubricate, and refill the equipment as necessary.
- Use various pieces of equipment to perform fine grading and finishing, sloping, and banking, backfilling, demolition, ditching, loading, excavating, and stockpiling.
- Operate equipment on public roadways, maintaining proper awareness of one's surroundings.
- Perform routine cleaning and maintenance to ensure smooth operation of the equipment.

- Builds relationships and develops communication and interpersonal skills with tradespeople and project team members, such as foremen, journeymen, superintendents, subcontractors, etc.

#### **WORK ENVIRONMENT**

While performing the duties of this job, the employee regularly works in outside weather conditions.
