### **POSITION SUMMARY**

The Site Health and Safety Officer is responsible for the overall safety of all elements at a specific project location consistent with the Site-Specific Health and Safety Plan and Corporate Health Safety Program.

### **FUNCTIONS OF THE POSITION**

- Develop, implement, and manage all Health and Safety (H&S) strategies and programs for the company, which includes leading and managing projects related to overall H&S strategy development, key performance indicators, benchmarking, and corporate policies and goals.
- Design, develop, implement, and maintain the H&S compliance programs to ensure compliance with the applicable federal, state, and local laws, rules, and regulations, and applicable company requirements.
- Interface with the company's Executive Team and middle management in the implementation and management of all H&S compliance programs.
- Develop, manage, implement, and train to requirements of Activity Hazard Analyses (AHAs) for construction and environmental remediation activities.
- Plan, develop, and implement safety training for new employee orientation and for current employees.
- Identify, evaluate, and abate hazardous conditions and practices in the workplace.
- Coordinate and conduct on-site inspections to audit physical conditions and safe work practices.
- Coordinate and manage any emissions testing and/or personnel exposure testing, including review and interpretation of testing and monitoring results and recommendations of opportunities for eliminating personnel exposures.
- Manage OSHA recordkeeping and reporting requirements.
- Manage the company's Safety Data Sheet (SDS) system.
- Manage and coordinate all activities associated with compliance for applicable environmental regulations, including but not limited to EM 385-1-1, CAA, CWA, CERCLA, RCRA, and TSCA.
- Responsible for ensuring timely preparation and submission of applicable environmental permit applications as necessary.
- Responsible for managing annual safety and environmental calendars to ensure timely submission and compliance with federal, state, and local regulations for all EHS reporting requirements.
- Prepare project planning documents such as the HASP, EPP, SPCC, SWPPP and hazardous waste minimization plans
- Manage NPDES and RCRA requirements and compliance strategies; ensure that all waste materials are properly identified/classified and arrange for cost effective off-site disposal.

- Ensure that accidents or incidents/near misses are appropriately reviewed, investigated, and reported in accordance with regulatory and company requirements, and that identified corrective actions are tracked and implemented in a timely manner.
- Develop and maintain the Company's written H&S program. Prepare PowerPoint presentations and training materials for H&S programs. Ensure all materials are completed and maintained clearly and professionally.
- Assist Engineering in projects that affect safety and environmental compliance.
- Assist Management in reviewing projects relative to proper levels and coverages for property, casualty, and pollution insurance.
- Conduct environmental and safety audits of the company's operations.
- Work with third-party contractor, when necessary, to provide training and orientation for on-site personnel.

### **PREFERRED EDUCATION AND EXPERIENCE**

The preferred candidate will have a Bachelor of Science degree in chemical engineering, industrial engineering, environmental engineering, occupational safety and health, chemistry, or a related field. They will also have a minimum of 3 years of experience as a safety officer on construction and/or environmental remediation projects.

The candidate will be knowledgeable of the applicable EHS regulatory regimes, including but not limited to: OSHA, USACE Safety and Health Requirements Manual EM 385-1-1, CAA, CWA, TSCA, RCRA, and CERCLA.

The candidate will have an understanding of safety protocols and requirements of federal customers, including USACE, EPA, DHS/CBP, NASA and others.

They will have the ability to read, research, interpret, and discuss laws, rules, and regulations and their impacts to company and/or project operations.
