# **Blended Learning Course Breakdown**

Below is a breakdown of the different options we have for blended learning courses. The employer ultimately decides what is sufficient training for workers when considering many elements including work environment, experience, types of equipment used, and so on.

All courses are built to meet Canadian Standards, as well as industry best practice. Where applicable, participants will be made aware of Saskatchewan specific legislated requirements in relation to the course topic.

Any blended training course that involves equipment on this document is an intro to operation and a safety-based course, not a competent operator course. The safe operation course can, however, be used as one of the elements of deeming a worker competent.

## First Aid- Full Course

**Certification by:** Canadian Red Cross

**Prerequisite:** None. This course can be taken by any participant that requires a full 16 hour course.

Timeline to complete both components: 6 weeks from registration

Exam: Participants will do a written exam during the in-class portion

**Online portion details:** The online portion of this course is assigned by Hutt's Trucking Ltd. and should take anywhere between 6-8 hours to complete. This must be completed before attending the classroom portion

**Classroom portion details:** The classroom portion applies skills that relate to the online portion and takes between 6-8 hours to complete.

## First Aid- Recertification

**Certification by:** Canadian Red Cross

**Prerequisite:** Participants must hold a valid First Aid certificate when registering.

**Exam:** Participants will do a written exam during the in-class portion

**Timeline to complete both components:** 6 weeks from registration AND completed before the expiry date on their current ticket

**Online portion details:** The online portion of this course is assigned by Hutt's Trucking Ltd. and should take anywhere between 3-4 hours to complete. This must be completed before attending the classroom portion

**Classroom portion details:** The classroom portion applies skills that relate to the online portion and takes between 4-4.5 hours to complete.



## H<sub>2</sub>S Alive- Renewal

**Certification by:** Energy Safety Canada

**Prerequisite:** Participant must be registered before the expiry date on their current ticket.

**Exam:** Participants will complete a true/false and multiple choice exam online upon completion of the online training

**Timeline to complete both components:** Both components must be completed within 90 days of registration

**Online portion details:** The online portion of this train is purchased directly from Energy Safety Canada at <a href="www.energysafetycanada.com">www.energysafetycanada.com</a> and will take 2-4 hours to complete.

**Classroom portion details:** The classroom portion of this training involves participants demonstrating the use of an SCBA and performing rescue drags. Participants should plan for 30-45 minutes to complete this element.

## Fire Extinguisher

**Certification by:** Hutt's Trucking Ltd.

**Prerequisite:** None

**Exam:** Participants will take an exam online following the online training

**Timeline to complete both components:** 60 days from date of registration

**Online portion details:** the online portion is delivered by The Canadian Red Cross and participants will learn the theory portion of using a fire extinguisher and the different types of extinguishers. This component takes 1.5-2 hours.

**Classroom portion details:** Upon completion of the online training, participants can arrange a time to do the practical element that involves the inspection of a fire extinguisher and then use a water filled extinguisher to put out a propane fire.

## Scissor Lift

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

Online portion details: Participants will learn theory as it relates to the use of scissors lifts and the hazards associated with the use of scissor lifts. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, use of fall protection, and safe operation of a scissor lift. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

## Boom Lift(EWP)

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of boom lifts and the hazards associated with the use of boom lifts. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, use of fall protection, and safe operation of a boom lift. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.



# **Bucket Truck**

Certification by: Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of bucket truck lifts and the hazards associated with the use of bucket truck lifts. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, use of fall protection, and safe operation of a bucket truck lift. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

# Stand Up Forklift

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of stand up forklifts and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

**Classroom portion details:** Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, and safe operation of a stand-up forklift. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.



Skid Steer

Certification by: Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of skid steer loaders and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

**Classroom portion details:** Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, changing of attachments, and safe operation of skid steer loaders. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

#### Tractor

Certification by: Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of tractors and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

**Classroom portion details:** Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, changing of implements, and safe operation of tractors. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

Wheel Loader

**Certification by:** Hutt's Trucking Ltd.

**Prerequisite:** None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of wheel loaders and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, changing of attachments, and safe operation of wheel loaders. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

#### **Overhead Crane**

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

Online portion details: Participants will learn theory as it relates to the use of an overhead crane and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, and the safe operation of an overhead crane. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.



Sit Down Forklift

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of sit down forklifts and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, and safe operation of a sit down forklift. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

# Pallet Jack Lift Truck

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of pallet jack lift trucks and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, and safe operation of a pallet jack lift truck. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.



# Telehandler Lift Truck

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

Online portion details: Participants will learn theory as it relates to the use of telehandler and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

**Classroom portion details:** Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, reading of load charts, and safe operation of a telehandler. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

# **Knuckle Picker Safety**

**Certification by:** Hutt's Trucking Ltd., this is not a Sask Apprentice Boom Truck Ticket

**Prerequisite:** None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of knuckle pickers and the hazards associated with the use of them. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

**Classroom portion details:** Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection, function test, and safe operation of a knuckle picker. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.



Basic Rigger/Signalman

**Certification by:** Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the use of rigging to lift loads, basic signaling. and the hazards associated with rigging and working around overhead loads. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection of rigging, the act of rigging loads, and signaling an operator. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.

# **Confined Space Entry**

**Certification by:** Hutt's Trucking Ltd.

**Prerequisite:** None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

Online portion details: Participants will learn theory as it relates to confined space and the hazards associated with these spaces. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves completing a hazard assessment on a confined space, space classification exercise, and atmospheric testing evaluation. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.



## **Fall Protection**

Certification by: Hutt's Trucking Ltd.

Prerequisite: None

**Exam:** Delivered in-class following the practical elements.

**Timeline to complete both components:** Both portions must be completed within 60 days of registration.

**Online portion details:** Participants will learn theory as it relates to the topic of working at heights, and the prevention of falls. This portion is assigned by Hutt's Trucking Ltd. and takes roughly 2 hours to complete but must be completed before attending the classroom portion.

Classroom portion details: Participants will take the knowledge they learned through the online training and apply it. This involves the pre use inspection of fall arrest equipment, fitting of a harness, and scenario-based discussion on the use of fall protection. A quick review of important Sask Legislation will be covered along with the written exam. Participants should expect the classroom session to last between 1.5-3 hours depending on the number of participants.
