Motion carried unanimously by vote of acclamation to approve. Motioned by Marsolek to have Atty Schaumberg do a draft of Markham addition and bring back to next council meeting, seconded by Skroch. Motion carried unanimously by vote of acclamation to approve.

High Crush/The Sand Mine- Derrick and Mitchell Bushman provided an updated on updating the plan for Reclamation Plan. They are having Kulig working on their rebidding. Atty Schaumberg provided an update with the Reclamation Plan and what would need to be reclaimed. Bushman Brothers will present a plan, and we will have Ayres look at it. Bushman Brothers were made aware of outstanding bills from High Crush a total amount of \$16,141.41. They asked if they could possibly get a break on the bills. This will be brought back to next meeting.

Street Superintendent Report- Eric provided an update garage doors don't fully seal. He replaced the water pump in the loader, and a switch in the street sweeper.
