Approval of Minutes – August 25, 2025: Motion by Craig Konter to approve the minutes from the August 25th, 2025, meeting as presented. Second by Jason Ekern. Motion carried unanimously by a vote of acclamation to approve.

Old Business:

- **A.** Facility Plan Review with Davy Engineering: Davy Engineering supplied an updated floodplain map; they are meeting with the DNR to go over map. Will need to update some of the building in the floodplain area.
- **B.** Water Pipe Survey: Still working on survey, 177 surveys left from the public.
- **C. Ferric Tank and Shed:** Installation almost complete just waiting for eye wash station and shower to be installed by Larson plumbing. DNR to do inspection once everything is complete.
- **D. Influent Pump:** Minnesota Pumps ordered parts and should be delivered this week.
- **E. Well Pump Inspection/Repairs:** Almost complete, there was an issue with a one way valve, Joe got it fixed without having to replace valve.
- **F.** Water & Sewer Truck: Joe received bids for cost of new truck for the city. Discussed different options to help save money with cost of truck such as taking lift gate from old city truck and putting it on the new truck. Joe is still waiting on more bids.
- **G.** Weekday Schedule: Joe discussed how he reached out to other municipalities about pay rates for water sewer employees during on-call time for weekdays. Water and Sewer commission will reach out to LEP committee to get recommendations on overtime and pay for weekdays.
- **H. 23235 Birch St. Water Bill:** Municipal Well & Pump will pay the water bill by giving the city a credit on the bill we will be receiving from Municipal Well & Pump for the work they did with the pump.
- I. Audit Report Update: Audit is complete. Mayor Tom Kloss went over the report from Auditors.

New Business:

A. Whitehall Road: Opened the floor to Dennis Suchla who discussed his issue with the pipe that had a leak under Whitehall road. Dennis dug up his front yard looking for the leak before discovering it was on the other side of the road. Dennis requested compensation for the cost of digging up his yard and replacing pipes in his basement. Committee asked him to get a total of all bills for the cost and bring back to next meeting. Whitehall road paving to be done this week. Joe discussed how the water pipes in the ground are transite pipes. Joe provided a report from Davy Engineering on different grant programs to help with cost of replacing pipes.
