Pre-Entry Fee: \$10 for each run

Day of show Entry: \$15 per run 9 AM-9:30AM Cash or checks only

Match Limit is 100 runs per day. The MATCH will be run according to UKC Nosework Rules.

The order for all trials is Novice to Elite.

Pre-entry Confirmations will be sent via e-mail as soon as possible after receipt of Pre-Entries. If you have not received confirmation by one week prior to the trial, please notify the Trial Secretary.

Grounds Information

On Saturday, the building will be open at 8:30 AM. Day of show entries will be taken from 9 - 9:30 AM. The Match starts at 10 AM.

Crating space will be available on a limited basis. The trial site requires a tarp to be placed on the floor underneath your crates.

Exhibitors are responsible for cleaning up after their dog(s) at the site in the designated potty area. Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show ground.

A Pot Luck Lunch will be provided by Paws For Fun members. Workers will eat free as a "thank you." Non-workers may also enjoy the lunch for a \$5 donation. There are also various restaurants and fast food vendors within a very short driving distance. No large coolers allowed in the facility.

UKC, Paws For Fun, R+K9, and Anderson Sheet Metal and Roofing are not responsible for loss, accidents or theft. By entering the trial, the participant waives all rights which he/she or their family may have or hereafter have against UKC, Paws For Fun, R+K9 and Anderson Sheet Metal and Roofing for occurrences over the trial weekend.
- Please be considerate of others and clean up after your dog at the trial site and motel facilities. Owners/handlers not cleaning up after their dogs are subject to dismissal from the trial without refund.

- Move Up Policy Moves ups can be submitted to the trial secretary immediately after one trial ends and before the next one begins. Move ups don't apply to this match since it is only 1 trial of each element.
- Entry fees will not be refunded in the event a dog is absent, disqualified, excused or the trial is canceled because of storms or other conditions beyond the control of Paws For Fun.
- After the trial closes, no refunds will be given except for bitches in season. In this case, a Veterinarian's certificate will be required.
- Bitches in season will not be allowed on the premises.
- Substitution Policy There will be no substitutions available at this event.
- Dogs must be kept on leash in the building and outside, unless otherwise directed.
- The Judge is not required to wait for any dog holding up the judging of a class.
- NO alcohol, illegal drugs, or SMOKING permitted on the grounds or buildings.
- Choke collars, pinch collars, electric and dummy electric collars are prohibited.

- 1. Elements are divided into Levels "N"-"E" and further divided into "A" and "B" sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching the elements chosen.
- 2. Handler Discrimination. In Novice, Advanced, and Excellent, one glove must be provided by the handler. In Master level classes a personal item according to the rules for this level.

 3. All entries must be submitted on the current "Official UKC.®
- 3. All entries must be submitted on the current "Official UKC® Nosework Trial Entry Form".
- 4. Use a separate entry form for each dog entered in a club's event.
- Nosework events are open to all UKC registered breeds and mixed-breed dogs with a valid Performance Listing/ Limited Privilege number/Permanent Registration/Temporary Listing.
- 6. We want you to keep the points earned at UKC Licensed events. Important things to remember:
- All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.
- Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com/tl-numbers. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
- All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
- 7. The United ennel Club complies with the Americans with Disabilities Act. If you require an accommodation, please contact the Event Chair or Secretary for this club's event.
