RPB Terms and Conditions (abbreviated)

1. RPB is the funeral business of RPB Funerals Ltd. It collects personal information about You and the deceased and any other person of which You supply details at the time of the funeral arrangement or product ordering ("Data"). The Data will be held on the computers (and other ways) of RPB Funerals Ltd.
2. In the event that any payment due from You to RPB is not made on the due date, RPB shall be entitled to receive interest on the late payment from the date the payment fell due until the date of actual payment (both before and after judgment) at an annual rate of interest equivalent to 1.5% above the base lending rate from time to time of the HSBC Bank plc to be calculated on a daily basis.
3. A full estimate of costs will be given at the time of arrangement. You shall be entitled to terminate the Agreement on not less than 48 hours written notice to RPB. If You terminate this Agreement, You will be liable for any costs incurred to the date of termination the RPB may have incurred as a direct result of Your order. RPB shall be entitled to terminate this Agreement at any time with written notice going to You.
4. We hold the rights to ask for a deposit to the value of the disbursements to be paid 48 hours before the funeral. A full invoice will be sent out after the funeral service and payment terms are 30 days from date of invoice.
5. These conditions and the written estimate of Your funeral requirements comprise all the terms of the agreement between RPB and You ("Agreement") and they shall govern the Agreement to the entire exclusions of all other terms and conditions save where expressly agreed otherwise in writing by the parties. These conditions will not release any party from liability of any fraudulent act.
