Meeting: The meeting was called to order at 7pm. Members present Bob Neumann Chair, Chad Walhowe Vice Chair, John Uecker Supervisor, Jami Berg Treasurer, Debbie Uecker Clerk, Gage Gutzmann & one residents.

Pledge of Allegiance: Recited.

Meeting Minutes: A motion to accept May 20th, 2025, monthly meeting minutes was made by Bob Neumann, 2nd by John Uecker and carried 3-0.

Treasurers Report: The ending balance for May is \$191,766.93, subtract the outstanding checks we have an actual balance of \$189,880.90 and deposits of \$1,463.00 from assessment search and dust control. A motion to accept the Treasurers' report was made by Bob Neumann, 2nd by Chad Walhowe and carried 3-0.

Maintenance Update:

Dust Control was completed on 6/18, removed trees on 25th for turn-around and will finish the project, Culvert on Hoyt Ave will be replaced, Culvert on 30th Street by Stejskal will need to be replaced.

A motion was made by Chad Walhowe, 2nd by Bob Neumann to send a bill to Albion Evangelical Free Church for \$850 for dust control and carried 3-0.

Next month: hooked up sprayer and ready to spray, mowing ditches.

Old Business:

1) A motion was made by Chad Walhowe, 2nd by John Uecker to approve the final completion of the work performed by Field's Contracting LLC for Hoyt Ave and carried 3-0.

2) 25th Street will have dirt hauled in to finish the project.

3) T413 road vacation will be recorded.

4) 50th Street will be completed upon contractor availability.

New Business:

1) Shane Suchy 2365 Kimball Ave NW PID 201-015-002020 was present to discuss a water runoff issue from the road. After discussions, a motion was made by Bob Neumann, 2nd by Chad Walhowe to authorize John Uecker and Gage Gutzmann to review the issue and fix the water issue and carried 3-0.

2) Jackie Roy 1702 Lawrence Circle is concerned over her neighbor's property; the property has a tree that fell on house. This is a private land matter and not a concern of the Township.

3) Corinna Township will be asking us to temporarily close Illsley Ave for a culvert replacement.
