Pledge of Allegiance: Recited.

Treasurers Report: The ending balance for December is \$338,840.95; subtract the outstanding checks we have an actual balance of \$335,955.38. Deposit from patronage refund. Motion to accept the Treasurers' report was made by John Uecker, 2nd by Chad Walhowe and carried 3-0.

Maintenance Update: fire extinguishers were updated, WH security system is being worked on and may need to replace the system and will get a quote from Wright Hennepin. Has 100 fire signs ready to be ordered for replacement, cleaned up down trees, fixed road signs.

Next Month: haul in scrap metal to French Lake, tree work, continue working on fire number signs, may go to Wright County Maintenance meeting, will get a few loads of rock chips, discussed disking of roads.

Old Business:

- 2) Discussed meeting room chair replacements, will be approximately around \$3K for chairs.
- 3) applied for .gov website and Debbie has not shopped for a new computer.
- 4) Discussed RFP for lawn service and will bring up at Annual Meeting.

- 1) Discussed Affidavit of Restitution on criminal damage to property on Patrick Michael Remer case of a total of \$2,844 (gravel and hauling \$2K, grading Township Road \$150, replacement of dust control \$694).
- 2) The Clerk and Treasurer's books were audited. Motion made by John Uecker, 2nd by Chad Walhowe to accept the board of audit and carried 3-0.
- 3) Discussed the annual meeting agenda and financial statements. John Uecker will get the 2026 Dust Control price.
