As an importer, distributor, and manufacturer for almost 29 years and several millions in revenues, the company continues to thrive and diversify in the supply chain solutions for the public and private sectors providing medical, safety, office, and cleaning supplies. EXCEL has been certified in several states as a woman, minority, DBE, SBA 8a, SBA Hub-zone, SDB, company since 1995. By utilizing resources offered by both the federal and local government, she competitively won bids thereby was awarded three federal GSA Contracts. Ms. Reyes has strong conviction in giving back to the community, equality, advocacy and achieving legislative actions for the benefit of woman and minority owned businesses. She was an Advisory Board Member for the Washington State Small Business Development Center, which is a U.S. Small Business Administration funded program that assists established small businesses grow to the next level.
