Cabarrus Health Alliance's COVID-19 staff are actively vaccinating individuals who fall within the Group 1 and Group 2. Definitions for each phase can be found below.

Tested, safe, and effective COVID-19 vaccines will help us defeat the virus, get back in control of our lives, and back to the people and places we love. GROUP 1: HEALTH CARE WORKERS & LONG-TERM CARE STAFF AND RESIDENTS

- Health care workers with in-person patient contact
- Long-term care staff and residents—people in skilled nursing facilities, adult care homes and continuing care retirement communities

GROUP 2: OLDER ADULTS

- Anyone 65 years or older, regardless of health status or living situation

GROUP 3: FRONTLINE ESSENTIAL WORKERS

- The CDC defines frontline essential workers as workers who are in sectors essential to the functioning of society and who are at substantially higher risk for exposure to COVID-19

GROUP 4: ADULTS AT HIGH RISK FOR EXPOSURE AND INCREASED RISK OF SEVERE ILLNESS

- Anyone 16-64 years old with high-risk medical conditions that increase risk of severe disease from COVID-19 such as cancer, COPD, serious heart conditions, sickle cell disease, Type 2 diabetes, among others, regardless of living situation
- Anyone who is incarcerated or living in other close group living settings who is not already vaccinated due to age, medical condition or job function
- Essential workers not yet vaccinated. The CDC defines these as workers in transportation and logistics, water and wastewater, food service, shelter and housing (e.g., construction), finance (e.g., bank tellers), information technology and communications, energy, legal, media, public safety (e.g., engineers) and public health workers

GROUP 5: EVERYONE WHO WANTS A SAFE AND EFFECTIVE COVID-19 VACCINATION

WHAT TO KNOW WHEN IT'S YOUR TIME TO GET VACCINATED.

Before you come, please:

1. Print and bring your completed [registration form](#) with you.
2. Bring a copy of your insurance card (front and back).
3. Bring proof of ID that qualifies you as being in Group 1 or proof of date of birth for Group 2.

Second Dose Appointment Scheduling

CHA will be opening second dose appointments on Monday, January 18, 2021. Individuals who have already received their first dose, were given a 'COVID-19 Vaccination Record Card'. The date on the back of that card is NOT an appointment, it is the first day the patient is eligible to receive their second dose:

- Pfizer second dose can be administered as early as 21 days after the first dose
- Moderna second dose can be administered as early as 28 days after the first dose

Health officials are asking individuals who received their first dose to monitor the COVID-19 Vaccine website for clinic dates that are on or after the date listed on the back of their 'COVID-19 Vaccination Record Card'.

FAQs

- **An appointment is required.** If an individual shows up more than 30 minutes prior to their appointment, they will be asked to return closer to their appointment time.
- Proof of residency is not required, but please consider attending a vaccine clinic in your community.
- If you have received any other vaccine in the last 14 days you are not eligible to receive the COVID-19 vaccine.
- Immigration status is not shared with anyone; however name and demographics are submitted to the North Carolina Department of Health and Human Services (NC DHHS) COVID Vaccine Management System (CVMS).
