II. Roll Call

III. League / Operations

-Registration is still open, we had a team register today for the Mon/Wed league.

-Leave it open until the AGM to try and get 48 teams

-Divisions will be even – need to stress league guidelines for new teams.

-Jamie to send a note out to all teams with a fee break down, to let them know they have been accepted into the league and an AGM reminder.

-Rule Changes -

-Bases should now be 70 ft apart, are we changing this? No, vote to add to operating guide but will this affect us if we are hosting provincials (No). Alyssa purposes, Jamie seconds, Dan thirds, vote open to add operating guide. Vote passed with no one opposed.

-Jamie purposes eliminating running out home runs, Dan seconds. Vote passed with no one opposed.

-Does anyone want to go back to 7 runs per inning or leave at 6 – no one wants to go back to 7.

IV. Finance

V. New Business

-There is a meeting on April 11 to go over the lease agreement with the City of Fort Saskatchewan. Adam and Alyssa will be attending but if anyone else wants to join, they are more than welcome to.

-Received the draft lease agreement, Alyssa will share this with the board so they can look through it, but it is confidential. If it's this high the league should be getting something out of it.

-It is quite high so we will start with some negotiations and go from there.

-Alyssa has been reaching out to other associations about what they pay and what that their lease provides for them as a comparison.

-Depending on the amount we may need to raise team fees by about \$300.00.

-Explore options of partnering with someone for naming rights if needed.

VI. Other

-Jamie has stuff for the team packages and we will give them out at the AGM.

-Brewhouse, pasta dinner vouchers, letter from Pots, Shelley is coming with coupons. Mike is working on some sponsors and might have stuff for the packages.

-We will not include rule books as all information can be found in SPN. We will put some out and teams can grab them if they want them.

-Winners swag from last year will be ready at the AGM and we will give out then.

-SPN prizing has changed. It has become custom for leagues for however many teams you have, you get that amount for prizing. You just order and pay for shipping.

-Wondering if we can get the league logo but the online store isn't live yet so Jamie could not check.

-Need to meet with Team Snap on a Friday in April to get it all sorted. Jamie will send an email to the rep and send it to Adam.

-Jamie will take over as Vice President but will continue to control Team Snap
