### ASSUMPTION OF RISK

I understand that participation in activities at The Pitbull Store Dog Gym, including but not limited to slat mill use, weight pull, wall climbs, treadmill use, interactive play, and training sessions, involves inherent risks of injury to myself, my dog(s), or others. I knowingly and freely assume all such risks, both known and unknown.

### HEALTH AND BEHAVIOR ACKNOWLEDGMENT

I affirm that my dog(s) are in good health and current on all vaccinations. Have not shown dangerous behavior toward people or other dogs - are under my control and supervision at all times during gym use. I understand that I am solely responsible for the behavior and safety of my dog(s) during all gym activities.

- Aggressive dogs may be allowed approval and must follow safety protocols (muzzle, private sessions, etc.)
- Dogs in heat are not permitted

### USE OF EQUIPMENT

- All gym equipment must be used as intended with care in regards to your dog's safety, ie, avoiding too much weight or ill-fitting harnesses, etc.
- The Pitbull Store is not liable for injury caused by improper use
- Your dog must remain on leash and under your control at all times

### RELEASE OF LIABILITY

In consideration of being allowed to use the facilities, equipment, and services provided by The Pitbull Store, I hereby release, waive, and discharge the owners, employees, volunteers, agents, and affiliates from any liability, claims, demands, or causes of action for injury, damage, or loss to myself, my dog(s), or my property. Participation is at my own risk.

## **INDEMNIFICATION**

I agree to indemnify and hold harmless The Pitbull Store and its representatives from all claims, actions, or liabilities for injury, damage, or loss arising from my or my dog's participation, including legal fees and court costs.

## **EMERGENCY CARE**

If my dog becomes ill or injured and I cannot be reached, I authorize The Pitbull Store to seek emergency veterinary care at my expense.
