With Don we learned how to carve in the round with bark. He showed us how to prepare both pieces of bark and glue them together temporarily while we rough shape our house. Then separate the two pieces and finish carving the doors and windows and then glue back together. I have seen it done in books and was excited to actually do it ourselves.

With Dick we carved a Santa face on a triangular piece of wood and then hollowed out the back side to make it lighter to be used as a Christmas ornament.
