# Proceedings of the Eighteenth Annual Session of the Solid Rock Association of Old Time Baptists of Jesus Christ September 8, 2017

Many brothers and sisters traveled from across the country to gather together at the Pilgrims Prayer Church in Dorton, Kentucky for the Eighteenth Annual Session of the Solid Rock Association of Old Time Baptists of Jesus Christ. After singing a few well-loved songs of Zion, our moderator, Elder Daryl Newsom, stood and welcomed everyone who had met out. He said that this ought to be God's day and that we have come together to strengthen in unity. He concluded by explaining that some people see God like a spare tire; they do not use Him until they absolutely need Him. Then Brother Daryl Newsom asked Elder Larry Hankins to open the services.

Brother Larry Hankins stood and said that this was an unexpected pleasure. He did not intend to preach, but he came ready. He went on to speak about all the natural disasters occurring in the world today. He declared, "It's not an EPA-problem; it's a sin-problem!" He spoke about how he came to the Lord at the age of twenty-six and how it did not take him long to get to where he is at today. He concluded his sermon by explaining that Jesus came to do the work that no man could do.

Elder Cullen Caudill lined, "Go Thou and Prophesy" and Elder Clyde Bentley led us in prayer. He thanked God for the beautiful congregation, the sunshine, and the breath that He had given us.

Brother Brandon Patrick sang, "He Knows Exactly What I Need" and Elder Elisha Justice delivered the Introductory Sermon. He explained how hard it was for him to preach the Introductory Sermon, because of seeing all his brothers around him. He talked about how different people have asked him about the signs of the last days and how he told them they needed to look up to the Lord. He concluded his sermon by telling a story about how his two-year-old niece wanted her dad to sing a song before she could go to sleep. #### Item-1

Elder Daryl Newsom called for the church letters to be handed in to the clerk, along with any contributions, obituaries, queries and/or requests. The clerk, Deacon Thomas Pinion, then read the letter from the **Canaan's Shore Church**. A move by Deacon Joey Justice and a second by Elder Chad Reinthaler was made to receive their letter and seat their delegates, along with **all** churches and delegates who submitted a letter in regular form.

**1A:** A move by Brother Chad Reinthaler and a second by Elder Larry Hankins was made to receive Hurricane Gap Church in as a member church.

#### Item-2

The moderator appointed Brother Joey Justice, Elder Fred Neeley, Elder Scotty Tackett, and Brother Tony Rowe to go back and take the vote for officer elections.

The officers selected to serve the association for the year were:

The officers agreed to serve this association to the best of their ability.

#### Item-3

Brother Daryl Newsom stood as moderator with a move by Brother Joey Justice and a second by Brother Charlie O. Shepherd for him to make all temporary appointments.

#### Item-4

Brother Daryl Newsom asked if the delegates would like the Charter, the Rules of Decorum, the Constitution and the Articles of Faith read or omitted from being read. A move by Elder Chris Newsom and a second by Brother Charlie O. Shepherd was made to omit reading the Rules of Decorum, Constitution and Articles of Faith, but to read the Charter.

After the assistant clerk, Brother Brandon Newsom, read the Charter, Brother Daryl Newsom admonished the brothers to obey the Rules of Decorum.

#### Item-5

The moderator called for any newly organized or duly constituted churches, who may desire membership with us and none responded.

#### Item-6

The moderator called for any associations or churches who may desire correspondence, or a working relationship with the Solid Rock Association, the following responded:

1. **Crossroads Baptist Church -** Clay City, KY, submitted a letter desiring to become a fellowship church of the association.

A move by Brother Chris Newsom and a second by Brother Larry Hankins was made to receive said church as fellowship church, seat them, and give them the righthand of fellowship. 2. **Southern Home Church of Old Regular Baptists** - Citra, FL, submitted a letter via email desiring to continue being a fellowship church of the association.

A move by Elder Jeremy Newsom and a second by Brother Charlie O. Shepherd was made to receive said church as fellowship church, seat them, and give them the righthand of fellowship.

#### Item-7

Brother Daryl called for transient ministers or members to sign in with the clerk at this time. The following responded:

#### Item-8

The moderator appointed a committee on finance consisting of the clerk and assistant clerk. He reminded the churches that all donations should be turned in to the clerk at this time. This committee is to give their report on Saturday morning.

#### Item-9

The moderator appointed a committee on ministry consisting of one delegate from each church, along with the entire delegation of the Pilgrim's Prayer Church. The committee recommended the following for Friday afternoon:

Prayer: Brother Leroy Fields
Second: Brother Mike Stanley
Close: Elder Scottie Tackett

#### Item-10

The Committee on Arrangements did not require meeting after the service Friday afternoon, as the requests sent in did not warrant further discussion.

#### Item-11

The moderator did not appoint a Committee on Resolutions being the Committee on Arrangements was not meeting. Typically, the purpose of this committee is to work with the Committee on Arrangements and write recommendations to come under consideration of the delegates for Saturday's work. This committee typically consists of association officers and one delegate from each member church.

#### Item-12

A move by Brother Charlie O. Shepherd and a second by Elder Clyde Bentley was made to adjourn the work for the day.

When Friday's business was finished, Brother Mike Stanley sang "He's My All and All". Elder Jeremy Newsom led in a prayer of dismission and asked a blessing over the food.

## Friday Afternoon September 9, 2016

Brother Fred Neeley sang "Almost Home" and introduced the services. by speaking on his own conversion. He described it as the Lord gave him a heart operation. He spoke about how Jesus said that He was the light of the world, but once He left, that His believers would become the light of the world. He concluded his sermon by telling about his granddaughter surviving a car accident just recently. He was so thankful that the Lord spared her, because she has been praying. Brother Cullen Caudill sang "Almost Supper Time" and Elder Leroy Fields led in prayer.

Brother Mike Stanley began to preach. He started by saying how he got a great blessing today and how one's light will shine when they become obedient to the Lord. He exclaimed, "Get yourself out of the way and drop your pride." He explained how Jesus paid the ultimate sacrifice for every man and woman that calls on Him. He concluded his sermon by recollecting on his recent visit to another church. He spoke about how he was blessed there just the same as he gets blessed at his home church. He stated, "Denomination doesn't matter; it's about love."

Brother Scottie Tackett came to the stand to close the service. He asserted that, "God loves you more than anything else in this world." He then went on to testify about having an aneurysm. The doctors told him that he was not going to make it; if somehow, he did pull through that he would be braindead. He declared that God was in control, not this world. He concluded his sermon by explaining how hatred was tearing families apart and how love moves in once you are covered with the blood of Jesus.

# Saturday Morning Proceedings September 9, 2017

After singing a few well-loved songs of Zion our moderator, Brother Daryl Newsom, welcomed all who had met out.

Elder Joe Carol sang "Because He Loved Me" and introduced the service. He considered it to be an honor to be invited to our association. He questioned, "Why did God allow His Son to go through what He did?" He clarified, "Because God loves His people." Brother Joe Carol believes that if he were the only person in the world that God would have still sent His Son to die for his sins, because his relationship with his Lord is personal. He declared, "God is my King and I am His son."

Brother Joey Justice sang "I Am Blessed" and began to pray. He asked the Lord to bless our work and continue to remember our little association.

Elder Larry Patton began to preach. He affirmed that he was glad to be a Christian. He explained that love was holding this world together and that our little gathering was all about love. He continued by saying that he believed that Heaven was going to be like our little gathering. He spoke about how Amos was his hero; he felt that he was a whole lot like us. A move by Brother Jeremy Newsom and a second by Brother Clyde Bentley was made for our clerks, Brother Thomas Pinion and Brother Brandon Newsom, to superintend the printing of the minutes. A move by Brother Charlie O. Shepherd and a second by Brother Larry Hankins was made to have 500 minutes printed. Then they are to distribute them to the churches.

Our moderator then called on the same committee on ministry as Friday to set service arrangements for Saturday afternoon and Sunday morning. The committee recommended the following:

#### Item-19

A move by Brother Joey Justice and a second by Brother Bud Cornett was made to have all Union, Communion, and Memorial meetings printed in the minutes. The move was extended to include printing the date and time of any other "special" meetings the churches want listed.

#### Item-20

A move by Brother Jeremy Newsom and a second by Brother Joey Justice was made to have the Constitution, Articles of Faith, Rules of Decorum and our Charter printed in the minute book.

#### Item-21

Brother Clyde Bentley, chosen by the delegates during the 2016 session to write this year's circular letter, came and read his circular letter. After reading his letter, a move by Brother Larry Hankins and a second by Brother Joey Justice was made to receive the letter as written and print it in the minute books.

#### Item-22

Brother Brandon Newsom stood to give a report on the association's website.

**22A:** A move by Brother Clyde Bentley and a second by Brother Charlie O. Shepherd was made to create a new website for the association.

**22B:** A move by Brother Charlie O. Shepherd and a second by Brother Jeremy Newsom was made to appoint a social media committee with Brother Brandon Newsom as the chairperson of the committee.

#### <u>Item-23</u>

The moderator called on the standing Committee on Council to see if they had been called upon during the past year. Our Assistant Moderator, Elder Cullen Caudill, reported the committee had been called upon.

Brother Thomas Pinion read the letter sent to the Lexington United Baptist Church from the Committee on Council. A move by Brother Joey Justice and a second by Brother Charlie O. Shepherd was made to retain the Committee on Council, recognize the need of the Lexington United Baptist Church, and try to fill it as much as possible.

The chairperson would be the assistant moderator of the association, Brother Cullen Caudill. Members of this council include all moderators, all assistant moderators, and all of the officers of this association.

#### <u>Item-24</u>

Brother Daryl Newsom appointed a teller, Brother Joey Justice, to tally a vote from all delegates on who will preach next year's introductory sermon and their alternate; as well as who will write next year's circular letter and their alternate. The delegates selected the following:

**25B:** The G. Bennett Adams Church put forth a request to add a "Dismissed" column to the membership letter and minute book. A move by Brother Charlie O. Shepherd and a second by Brother Chris Newsom was made to grant their request.

**25C:** The Hurricane Gap Church put forth a request to host the 2018 Communion-Fellowship meeting. A move by Brother Joey Justice and a second by Brother Jeremy Newsom was made to grant their request.

#### Item-26

A move by Brother Joey Justice and a second by Brother Charlie O. Shepherd was made to have the clerk write a letter dedicating this year's minutes to the deceased members of our association who have died since last year.

#### **Item-27**

A move by Brother Larry Hankins and a second by Brother Chris Newsom was made to have the assistant clerk write a letter of thanks to the hosting church, the Pilgrims Prayer Church, for their work and hospitality during the 2017 Solid Rock Association.

#### <u>Item-28</u>

A move by Brother Jeremy Newsom and a second by Brother Bud Cornett was made to allow the clerks to make any and all grammatical corrections in the publishing of the minutes upon approval of the moderators of the member churches.

#### Item-29

There being no further work to be done, a move by Brother Charlie O. Shepherd and a second by Brother Joey Justice was made to cease work for the day and to adjourn the Eighteenth Annual Session of the Solid Rock Association of Old Time Baptists.

After the association work was finished, Brother Josh Newsom lined "To See a Pilgrim as He Dies" and Brother Jason Bishop led in prayer. He asked God too to bless those who came out.

## Saturday Afternoon Service September 9, 2017

After singing a few well-loved songs of Zion, Brother Daryl Newsom spoke about how thankful he was. Brother Joe Grimm sang "Come Sup with Me" and began to preach. He said, "I determine I know nothing among you except Jesus and Him crucified." He declared that some diseases have been or will be cured. He continued by saying, "The one disease there is no cure for is sin-sickness, because the cure of that disease was nailed to a cross 2,000 years ago." He concluded his sermon by saying that he was glad that he cried out to Him one time, because then he felt the weight of the world lifted off his shoulders.

Brother Joey Justice sang "The Shepherd Boy" and Elder Josh Newsom led us in prayer. He thanked the Lord for our association. He finished by thanking the Lord for him being able to have his children with him today.

Brother Corey Mullins sang "Nobody's Fault but Mine" and Brother Chad Reinthaler began to preach. He discussed his conversion and how God called him at the early age of 17. He declared, "Sometimes the road gets rough." He spoke on Elisha slaying the prophets of Jezebel and how the Lord gave him a little cake to eat. He continued by saying, "God has each one of us in the palm of His hand no matter how rough things get." He concluded his sermon by recalling when he first felt like the Lord was calling him to preach. A man had stopped by at the sawmill and Brother Chad Reinthaler told him about how he felt called to preach. The man admitted he did not need any lumber and told Brother Chad Reinthaler to do whatever God bids him to do.

Ethen Bentley sang "Lay My Crown at the Master's Feet" and Brother Jeremy Newsom began to preach. He stated, "I have truly enjoyed this weekend; it's been a blessing to me." He went on to explain that anyone can find an excuse not to do what the Lord wants them to. He told some stories of how he had experienced what this world had to offer: vanity and vexation. He compared himself to Gideon in the way he was always wanting a sign or another witness. He concluded his sermon by asking the congregation, "Aren't you glad that Jesus came for the poor, the meek, and the humble?"

Brother Joey Justice sang "Shepherd of My Valley" and Brother Brandon Newsom began to preach. He discussed how good he felt and how he could float all the way back home to North Carolina. He recollected on his experience of coming to the Lord during Y2K. Brother Brandon could feel the Lord working on him. He said, "I left a little meeting that night and things felt a little different." He explained, "You're either on the boat or you're standing on the shore." He discussed the events leading up to and including Christ's crucifixion. He declared, "My Lord dies so everything was possible." He concluded his sermon by asking the congregation to, "Make it real," because "it's not a fantasy," and to "read it as though it was one of your family members."

Brother Josh Newsom sang "Lord You're the Best Thing" and Brother Jonah Justice led in a prayer of dismission.

# Sunday Morning Service September 10, 2017

After singing a few well-loved songs of Zion, Elder Mike Newsom welcomed all who had met out. Brother Cullen Caudill lined "I Have Started for Thy Kingdom" and Brother Joey Justice led in prayer with the laying on of hands.

Brother Clyde Bentley came after prayer preaching about how God had been wonderful all weekend. He then sang "How I Come to Love These Pilgrims". He proclaimed, "The Bible teaches me that there's a way that seems right unto this world, but there's another way that will get us to Jesus." He explained how John came before Jesus and how he came to bear witness of Jesus. He spoke about how we need to be concerned with crossing bridges rather than building walls. When speaking on grudges he said, "We have to forgive and move on." He concluded his sermon by saying, "You can say you love Him with your mouth, but your heart better be on the right side."

Then Brother Chris Newsom came after and began to preach. He declared, "When God lifts me up there's nothing else I'd rather do," than to preach. He spoke on how some churches are more about what is in it for them rather than saying what can we do for the Lord. He said, "The majority of the world is not serving my Lord." He told about how Paul persecuted Christians before the Lord spoke to Paul about knowing it was hard for Paul to kill Christians. He told the congregation that, "If you are not following my Lord then you know it." He explained how the devil does not tell anyone to go to church or to send up a prayer. He proclaimed, "You are either serving my Lord or the devil." He concluded his sermon by speaking on his own conversion as a Christian.

Brother Cullen Caudill lined "Troublesome Waters" and then began to preach. He spoke about how even those who tried to find God would find themselves in some troublesome water at times. He told the congregation that the Lord is, "seeking and calling people out of darkness unto light." He spoke about how most people do not think of God when things are going smooth. He explained that the Lord wants us to seek Him on our sunshiny days, as well as the dark. He spoke about how Pilate washed his hands before Jesus was crucified to symbolize him washing the blood of Jesus off his hands. He continued by saying, "There is not enough water in the U.S. to wash the blood of Jesus off of our hands." He concluded his sermon by saying, "If you don't know Him when He comes, you would have been better off never being born."

Brother Daryl Newsom sang "See the Christians" and began to preach about Zacchaeus being visited by Jesus at a tree. Jesus said salvation would come into Zacchaeus' home. He then recalled when Sister Lisa joined the church and he asked her if she felt like God had saved her soul. She responded that she hoped so. He then recollected his own conversion of becoming a Christian. When his younger brother joined the church before he did, he thought he had missed it. He concluded his sermon by telling the congregation that, "The greatest gift you can give your family is to serve my Lord."

# Circular Letter By: Clyde Bentley

Dear brothers and sisters of the Solid Rock Association,

### Constitution

From a long series of experiences, we the churches of Jesus Christ, being legally baptized upon a profession of our faith in Christ, and convinced of the necessity of a combination of churches in order to have a union and communion among us, and preserve, perpetuate, and maintain a correspondence with each other in our union, we therefore propose to keep the order and rules of an Association, in accordance with the following plan, or form, of government:

- **Article 1.** The Association shall be called the *Solid Rock* Association of Old Time Baptist of Jesus Christ.
- **Article 2.** The Association shall be composed of three (3) delegates from each church in our association, along with the elected officers. These delegates shall be duly sent to represent their church in the Association. They shall be members whom their church judge best qualified for that purpose. Upon producing letters from their respective churches, certifying their appointment, they shall be entitled to seats.
- **Article 3.** Each church letter shall bear their annual statistics for numbers: in fellowship, baptized, received by letter, received by recommendation, received by restoration, dismissed by letter, dismissed by request, excluded and deceased.
- **Article 4.** The delegates thus chosen and convened shall have no power to lord anything over God's children, nor shall they have any clerical power over the churches, nor shall they infringe on any of the internal rights of any church in our union.
- **Article 5.** The Association, when convened, shall be governed by a regular and proper decorum.

- **Article 6.** The Association shall have a Moderator, Assistant Moderator, Clerk and Assistant Clerk. Each shall be chosen separately by a majority vote of the delegates present.
- **Article 7.** Any church petitioning, for either full membership or fellowship status, is to submit formal paperwork to the Association at the annual Solid Rock Association meeting. They will fall under the watch care of the Association's Committee on Council for an examination period of one year. If, at the conclusion of the examination period, they are found to be orthodox and orderly, per report by the Committee on Council, they shall be received by the Association, and manifested by the Moderator, who shall give them the right hand of fellowship.
- **Article 8.** Every church in the union shall be entitled to representation in the Association.
- **Article 9.** Every query presented by a church to the Association, being first debated in their own church, shall come under the consideration of the Association.
- **Article 10.** Every motion made and seconded shall be considered by the Association, unless it be withdrawn by the party who made it.
- **Article 11.** We think it absolutely necessary that we have an Association fund, for defraying the expenses of the same. We think it the duty of each church in the union to contribute such sums as they think proper, and to send it by their delegates to the Association. Such sums shall be deposited in the hands of the Treasurer, chosen by the Association, who shall be accountable for the money.
- **Article 12.** There shall be an Association Book kept wherein the proceedings of every association shall be recorded by a Secretary appointed by the Association. The Secretary shall receive annual compensation for his services.

- **Article 13.** The minutes of the Association may be read, and corrected if need be, and shall be signed by the Moderator and Clerk before the Association arises, unless the same is dispensed with. All queries, requests and resolutions which have been debated in the current association, shall be read back.
- **Article 14.** Amendments to this plan of government can only be made by unanimous decision of the union, if deemed necessary.
- **Article 15.** The Association shall endeavor to furnish the churches with minutes of the Association; the best method of effecting the same shall be determined by the Association.
- **Article 16.** All matters coming before the Association shall be decided by a will of the majority of the delegates present.
- **Article 17.** The Association is to remain as an advisory council, and not as an administrative government. Each church SHALL hold its own Ecclesiastical Keys. Each church shall be the sole judge of its members' conduct. Each church shall also have the right to decide who is worthy of membership, office or ordination.

### **Article 18.** This Association shall have the power to:

- **A.**) Provide for the general union of the churches, and to preserve an inviolable chain of communion between them:
- **B.**) Give the churches all necessary advice in matters of church difficulty;
- **C**.) Inquire into the cause as to why any church shall fail to represent themselves at any time in the Association;
- **D**.) Appropriate the money contributed by the churches for any purpose it may think proper;
- **E**.) Appoint any member, by their consent, to transact any business it may think necessary;

### Solid Rock Association

- **F.**) Withdraw from any church in the union that does violate the Constitution, Articles of Faith or Rules of Decorum of the Association, or deviates from the orthodox principles of the Word of God as found in the book of Hebrews 6:1-2;
- **G**.) To admit any orderly minister of our faith and order to a seat in the Association;
- **H**.) To adjourn to any future time and place it deems convenient.

### **Articles of Faith**

- **Article 1.** We believe in one true and living God (1 Cor 8:6): Father, Son and Holy Ghost (1 John 5:7); and these three are one (John 14:8-11).
- **Article 2.** We believe the scriptures of the Old and New Testaments, as translated in the King James Version, to be the inspired written word of God (2 Timothy 3:16; 2 Peter 1:21). The New Testament is the standard of faith and the ONLY authorized rule of faith and practice to the church of God under the gospel dispensation (Gal 5:4).
- **Article 3.** We believe in the doctrine of election by Grace (Acts 10:43; Eph 2:8). We do not believe in particular election (Titus 2:11; Rom 10:13) and reprobation, so as to make God partial directly, or indirectly, or to injure any of the children of men.
- **Article 4.** We believe in the doctrine of original sin (*Rom* 5:12), and of man's inability to save himself from the fallen state he is in by nature; therefore, the Savior is needed for our redemption (*Rom* 5:17-19; *Eph* 2:8-9).
- **Article 5.** We believe that sinners are called *(Mark 2:17)*, converted, regenerated and sanctified by the Holy Spirit *(1 Peter 1:23)*, and that all who are so regenerated and born again by the Spirit of God, shall never fall finally away *(Eph 1:13; Heb 10:14)*.
- **Article 6.** We believe that sinners are justified in the sight of God (Acts 13:39; Luke 18:13-14) only by the imputed righteousness of Jesus Christ in obedience to the calling of repentance (2 Timothy 1:9).

**Article 7.** We believe that baptism, the Lord's Supper and feet washing are ordinances of Jesus Christ (*Matt 3:13; Matt 26:26-29; John 13:4-14*), and that true believers are the only proper subjects of these sacraments. And, we believe the only true mode of baptism is by immersion after receiving the spiritual baptism of the Holy Ghost (*Rom 6:4*).

**Article 8.** We believe in the resurrection of the dead **(Luke 24:46; I Cor 15:51-53)**, and a general judgment, and that the joys of the righteous **(1 Thess 4:16-17)** and the punishment of the wicked will be eternal **(John 5:28-29)**.

**Article 9.** We believe no minister has the right to administer the ordinances of the gospel, unless He has been called **(Rom 10:15; 1 Cor 2:4)** and has come under the imposition of hands by a presbytery of the church **(Acts 13:2-3; Titus 1:5-15)**.

**Article 10.** We believe that every doctrine that goes to encourage or indulge people in their sins (1 Cor 5:2), or causes them to settle down on anything short of saving faith in Christ for salvation (Matt 7:13-14; Matt 7:21; Luke 13:23-24), is erroneous and such doctrine shall be rejected by us (Gal 1:8-10).

**Article 11.** We believe that all people reaching the age of accountability must be born again (*Rom 7:9-10; John 3:3*). We believe that all children dying in infancy, having not actually transgressed against the law of God (*Rom 4:15*), are only subject to the first death which was brought on them by the fall of the first Adam. No child dying in that state shall suffer punishment in hell by the guilt of Adam's sin (*Matt 18:1-5*).

**Article 12.** We believe that God is not willing that any should perish, but that all should come to repentance and the knowledge of the truth, that they might be saved **(2 Pet 3:9; John 3:16)**. All men, at one time or another, are found in such capacity as that through the grace of God they may be eternally saved **(Rom 5:18)**.

**Article 13.** We believe that Christ has but one true and gospel church, and that it will finally persevere through grace to glory *(Matt 16:18; 1 Cor 12:13)*. When the trump shall sound, the Son shall deliver up his church and present it to his Father, and so shall we ever be with the Lord *(1 Thess 4:16-17)*.

**Article 14.** We believe that the Church is a congregation of faithful believers in Christ who have obtained fellowship with the Lord and with one another (*Acts 2:41-42; 1 John 1:3*). Jesus Christ is the head of the church, and the government thereof is upon His shoulders (*Eph 5:23-24*).

### **Rules of Decorum**

- **Article 1.** The Association shall be opened and closed with prayer.
- **Article 2.** The Moderators and Clerks of the Association shall be selected by the delegates who are present.
- **Article 3.** Only one member shall speak at a time, and shall rise from his seat and address the Moderator when he is about to speak.
- **Article 4.** The person speaking shall not be interrupted in his speech by anyone, except the Moderator, until he is done.
- **Article 5.** The person speaking shall strictly adhere to his subject, and in no way reflect on the preceding speaker, but shall define his ideas on the proposition for debate so far as he can.
- **Article 6.** No person shall abruptly absent himself from the Association without leave of the same.
- **Article 7.** No member shall rise to speak more than three times on any one subject, without permission from the Association.
- **Article 8.** No member of the Association shall have the liberty to laugh during the Association, nor whisper in time of public speech.
- **Article 9.** No member shall address another in any other form or term other than that of "Brother" or "Sister."
- **Article 10.** The Moderator shall not interrupt a Brother, or prohibit him from speaking, until he gives his views on the subject, unless he has violated the Rules of Decorum.
- **Article 11.** The names of the several members of the Association shall be enrolled by the Clerk, and called over as often as the Association may require.

**Article 12.** The Moderator shall be entitled to the same privilege of speech as any member, provided the chair be filled. But, he *shall have no vote*, unless the Association be equally divided. In this event, he shall give the deciding vote.

**Article 13.** Any member who shall willfully and knowingly violate any of these rules shall be reprimanded by the Association as it may think proper.

### Resolutions

- **Article 1.** We believe that our article of faith #10 rejects sin, including homosexuality. We also believe that marriage is a union between a man and a woman, neither of which gender has been altered. It is further agreed that our ministers refrain from marrying people into this ungodly sin. (Adopted in 2004 minutes)
- **Article 2.** In regard to letters of dismission, the association recognizes the complexity of this issue and agrees that this request falls under article #17 of our constitution, which states: *The association is to remain as an advisory council and not as an administrative government. Each church shall be the sole judge of its members conduct. Each church shall also have the right to decide who is worthy of membership, office or ordination. (Adopted in 2004 minutes)*
- **Article 3.** We agree that several churches have already established a method of receiving previously ordained members into their fellowship. We recommend that the churches take care to uphold our articles of faith and constitution already established, particularly article of faith #9, and we note that the laying on of hands to issue credentials is an accepted practice with in our union. (Adopted in 2004 minutes)

**Article 4.** Under Article 7, any church organized under the authority of the Solid Rock Association, seeking membership, shall be immediately received and given the right hand of fellowship. This Article shall include any new associations seeking correspondence. Being a full member church of the Solid Rock Association grants voting rights to delegates, qualification to have members selected to preach the Introductory Sermon, and to write the Circular Letter. Fellowship churches only, are extended the right hand of fellowship as individual churches but do not have these authoritative rights. (Adopted in 2016 minutes)

**Article 5.** Under Article 14, the term "plan of government" pertains to the Association foundational documents including the Charter, Constitution, Articles of Faith, and Rules of Decorum. This does not apply to Article 16, which pertains to standard Association matters. (Adopted in 2016 minutes)
