### Charter

### Proceedings of the Nineteenth Annual Session of the Solid Rock Association of Old Time Baptists of Jesus Christ September 7, 2018

(Before services began Friday morning, our moderator, Elder Daryl Newsom, stood and mentioned a traffic incident that would cause some of the delegates to be late. He asked the delegates present to postpone Friday morning's church work by starting with the preaching portion of service. The work portion would follow dinner, allowing ample time for the delegates to arrive. Consent with no objection was given by all delegates present to modify our typical arrangements in this manner. Due to this, our Introductory Sermon was preached on Saturday morning instead of Friday.)

Many brothers and sisters traveled from across the country to gather together at the Pilgrims Prayer Church in Dorton, Kentucky for the Nineteenth Annual Session of the Solid Rock Association of Old Time Baptists of Jesus Christ. After singing a few well-loved songs of Zion, our moderator, Elder Daryl Newsom, stood and welcomed everyone who had met out. Brother Daryl Newsom asked Elder David Nichols to open the services. Brother David Nichols began by speaking about how excited he was to come to the association meeting this morning and how he did not think he would have to stand. He then explained how excited he was that God was moving in the Lexington United Baptist Church. Brother David announced that the door of mercy is still open. He then preached the parable of the king's wedding feast. Brother David said, "I don't have time for foolishness; I only have time for love and mercy."

Elder Paul McClanahan lined, "The Church" and Elder William Adair, Sr. led us in prayer. He asked the Lord to bless and strengthen us.

Elder Mike Stanley began his sermon by saying, "I read where it says to always stand ready." Then he sang, "Hold On" and told how he believed he had first put his hands on that plow in 2001. He explained that if he had anything in this world it was because God had blessed him. He spoke about how he had cried out to God many times before, but there was something different the time he cried out and God saved him. He said, "I need God as my personal Savior." Brother Mike said that we need to put on the whole armor of God.

Brother William Adair, Sr. sang, "Where the Soul Never Dies" and Elder Paul McClanahan came to preach. He called out, "If you don't want to be loved, then don't come to the Pilgrims Prayer Church." He explained that if medical science had not come up with a battery, then he would not have been able to be at the association meeting today. Brother Paul spoke about how the many miles he had traveled for the Lord would be worth it if it caused a sinner to repent. He sang, "Keep Your Lamps Trimmed and Burning" and then spoke about how he could not thank God enough for all that He had done for him. Brother Paul said, "I don't have much money in this world, but I'm one of the richest men in the world." Elder Cullen Caudill sang, "Here I Am" and Brother Joe Grimm led in prayer. He asked a blessing on the food.

### Friday Afternoon September 9, 2018

After singing a few well-loved songs of Zion, Elder Joey Justice led us in prayer. He told the Lord that he was blessed beyond measure. Then Brother Daryl stood and declared the Nineteenth Annual Session of the Solid Rock Association open, seated, and in working order.

#### Item-1

Elder Daryl Newsom called for the church letters to be handed in to the clerk, along with any contributions, obituaries, queries and/or requests. The assistant clerk, Elder Brandon Newsom, then read the letter from the **Hurricane Gap Church**. A move by Brother Charlie O. Shepherd and a second by Elder Larry Adkins was made to receive their letter and seat their delegates, along with **all** churches and delegates who submitted a letter in regular form.

#### Item-2

The moderator appointed Deacon Thomas Pinion, Deacon Joey Justice, and Elder William Adair Sr. to go back and take the vote for officer elections.

The officers agreed to serve this association to the best of their ability.

#### Item-3

Brother Daryl Newsom stood as moderator with a move by Brother Joey Justice and a second by Elder Jeremy Newsom for him to make all temporary appointments.

#### Item-4

Brother Daryl Newsom asked if the delegates would like the Charter, the Rules of Decorum, the Constitution and the Articles of Faith read or omitted from being read. A move by Brother Joey Justice and a second by Elder Larry Hankins was made to omit reading the Rules of Decorum, Constitution and Articles of Faith, but to read the Charter.

After the assistant clerk, Brother Brandon Newsom, read the Charter, Brother Daryl Newsom admonished the brothers to obey the Rules of Decorum.

#### Item-5

The moderator called for any newly organized or duly constituted churches, who may desire membership with us and none responded.

#### <u>Item-6</u>

The moderator called for any associations or churches who may desire correspondence, or a working relationship with the Solid Rock Association, the following responded:

1. **Shiloh Primitive Baptist Association -** Elkin, NC, submitted a letter of correspondence to the association.

A move by Brother Jeremy Newsom and a second by Brother John Cornett was made to receive said association, establish a working relationship, and give them the right-hand of fellowship. 2. **Southern Home Church of Old Regular Baptists -**Citra, FL, submitted a letter desiring to continue being a fellowship church of the association.

A move by Brother Charlie O. Shepherd and a second by Brother Clyde Bentley was made to receive said church as fellowship church, seat them, and give them the righthand of fellowship.

#### Item-7

Brother Daryl called for transient ministers or members to sign in with the clerk at this time. The following responded:

#### Item-8

The moderator appointed a committee on finance consisting of the clerk and assistant clerk. He reminded the churches that all donations should be turned in to the clerk at this time. This committee is to give their report on Saturday morning.

#### Item-9

At this time typical operation would see the moderator appoint a committee on ministry consisting of one delegate from each church and the entire delegation of the hosting church. Due to the circumstances, which required rearranging of Friday's church work and service, the committee on ministry was not called upon at this time.

#### <u>Item-10</u>

The Committee on Arrangements did not require meeting after the service Friday afternoon, as the requests sent in did not warrant further discussion.

#### <u>Item-11</u>

The moderator did not appoint a Committee on Resolutions being the Committee on Arrangements was not meeting. Typically, the purpose of this committee is to work with the Committee on Arrangements and write recommendations to come under consideration of the delegates for Saturday's work. This committee typically consists of association officers and one delegate from each member church.

#### Item-12

A move by Brother Charlie O. Shepherd and a second by Brother Larry Adkins was made to adjourn the work for the day.

When Friday's business was finished, Brother Joey Justice sang "I am Blessed". Elder Clyde Bentley led in a prayer of dismission and asked a blessing over the food.

### Saturday Morning Proceedings September 9, 2018

After singing a few well-loved songs of Zion our moderator, Brother Daryl Newsom, welcomed all who had met out.

Elder Rodney France came forth to introduce the services. He said, "We want to thank God for being the author and finisher of our faith." He spoke about how God does things sometimes that we do not like. Brother Rodney explained how he did not like it when God called him to preach, but that it was what He wanted. He expounded that God owns everything and He will do with it what He pleases. Brother Rodney concluded his sermon by saying, "You'll get no satisfaction with pleasing yourself."

Josh Newsom lined, "Savior's Call" and Brother Chad Fletcher led us in prayer. He thanked God for the congregation and this association.

Elder Jeremy Newsom, being selected to preach this year's introductory sermon, was then called upon. He explained that he had been to the last fifteen association meetings, but he had not looked forward to coming to one any more than he had this year's. He said that we needed to leave denomination outside and that we need to focus on love. Brother Jeremy spoke about his trip to Poland for work. He admitted that he could not speak their language, but that did not stop him from attending a church service during his visit. When they held prayer, Brother Jeremy dropped to his knees and began to pray the only way he knew how. When he had finished praying he could not hear anyone else and when he got up all eyes were on him. Brother Jeremy said, "God doesn't need a language." With the preaching being ended, Brother Daryl stood so the association's work could begin.

A move by Elder David Nichols and a second by Brother Larry Hankins was made to receive this report and discharge the committee.

#### Item-17

A move by Brother Jeremy Newsom and a second by Brother Joey Justice was made for our clerks, Brother Thomas Pinion and Brother Brandon Newsom, to superintend the printing of the minutes. A move by Brother Joey Justice and a second by Brother Larry Adkins was made to have 600 minutes printed. Then they are to distribute them to the churches.

#### <u>Item-18</u>

Brother Daryl asked for, and received, a move by Brother Joey Justice and a second by Brother Larry Adkins to have all obituaries printed in the minutes. This move included printing all obituary pictures at no expense to the family.

#### <u>Item-19</u>

A move by Deacon John Cornett and a second by Brother Larry Hankins was made to have all Union, Communion, and Memorial meetings printed in the minutes. The move was extended to include printing the date and time of any other "*special*" meetings the churches want listed.

#### <u>Item-20</u>

A move by Brother Joey Justice and a second by Deacon Tony Rowe was made to have the Constitution, Articles of Faith, Rules of Decorum and our Charter printed in the minute book.

#### <u>Item-21</u>

Brother Josh Newsom, chosen by the delegates during the 2017 session to write this year's circular letter, came and read his circular letter. After reading his letter, a move by Brother Jeremy Newsom and a second by Brother John Cornett was made to receive the letter as written and print it in the minute books.

#### Item-22

Brother Brandon Newsom stood to give a report on the association's website. A move by Brother Joey Justice and a second by Brother Larry Hankins was made to retain the social media committee with Brother Brandon Newsom as the chairperson and to keep the association website.

#### <u>Item-23</u>

The moderator called on the standing Committee on Council to see if they had been called upon during the past year. Our Assistant Moderator, Elder Cullen Caudill, reported the committee had not been called upon.

The chairperson for this committee is the assistant moderator of the association, Brother Cullen Caudill. Members of this council include all moderators, all assistant moderators, and all officers of this association.

#### Item-24

Brother Daryl Newsom appointed tellers, Brother Thomas Pinion, Brother Joey Justice, and Elder Chris Hughes to tally a vote from all delegates on who will preach next year's introductory sermon and their alternate; as well as who will write next year's circular letter and their alternate. The delegates selected the following:

#### <u>Item-25</u>

There being three items from the Committee on Arrangements, each was read and addressed at this time:

**25A:** The Shiloh Primitive Baptist Association put forth a request desiring correspondence with the Solid Rock Association. A move by Brother Joey Justice and a second by Brother Larry Hankins was made to grant their request. Then there was a move by Brother Joey Justice and a second by Brother John Cornett that we send delegates and a letter of correspondence to the Shiloh Primitive Baptist Association by having Elder Chris Newsom carry the letter.

**25B:** The G. Bennett Adams Church put forth a request to host the 2019 Solid Rock Association Communion-Fellowship meeting. A move by Brother Michael Stanley and a second by Brother John Cornett was made to grant their request and that we try fill it as much as possible.

**25C:** With there being no request made to host the 2019 Solid Rock Association, the Pilgrims Prayer Church requested to host the 2019 Solid Rock Association. The Lexington United Baptist Church then asked to co-host it with the Pilgrims Prayer Church. A move by Brother Michael Stanley and a second by Brother John Cornett was made to grant their request.

#### <u>Item-26</u>

A move by Brother Joey Justice and a second by Brother Jeremy Newsom was made to have the clerk write a letter dedicating this year's minutes to the deceased members of our association who have died since last year.

#### Item-27

A move by Elder Mike Newsom and a second by Brother David Nichols was made to have the assistant clerk write a letter of thanks to the hosting church, the Pilgrims Prayer Church, for their work and hospitality during the 2018 Solid Rock Association.

#### Item-28

A move by Brother Joey Justice and a second by Brother Larry Adkins was made to allow the clerks to make all grammatical corrections in the publishing of the minutes.

#### <u>Item-29</u>

There being no further work to be done, a move by Brother Joey Justice and a second by Brother Larry Hankins was made to cease work for the day and to adjourn the Nineteenth Annual Session of the Solid Rock Association of Old Time Baptists.

After the association work was finished, Brother Joey Justice sang "Gloryland" and Elder Cullen Caudill led in prayer. He thanked God for His many blessings of grace, mercy, and love.

### Saturday Afternoon Service September 8, 2018

After singing a few well-loved songs of Zion, Elder Cullen Caudill began to preach. He proclaimed, "I am nothing without God." Then he spoke about how he had to get himself in shape when he lost his joy. Brother Cullen had asked God to restore the joy of his salvation, because he wanted to feel His glory. Brother Cullen concluded his sermon by explaining how God gave him back the joy of his salvation one day when his was stopped at a red light on Route 80.

Brother Chad Fletcher sang, "Shepherd of My Valley" and Elder Paul Younce led us in prayer. He asked the Lord to continue to bless this association.

Brother William Adair, Sr. lined "I am Bound for the Promised Land" and Brother Chad Reinthaler led in a prayer of dismission. He thanked God for all his brothers, sisters, and His Spirit.

### Sunday Morning Service September 9, 2018

After singing a few well-loved songs of Zion, Elder Daryl Newsom welcomed all who had met out.

Elder Clyde Bentley began to preach. He said, "These last two days have uplifted my soul." He spoke about how God loves His children and He loves to bless them. Brother Clyde told the congregation that if they did not know God, then they were in the right place. He asked, "If you were to gain the whole world and lose your soul, what would you give?" Brother Clyde explained that we need to live in love for one another by telling a story about two carpenter neighbors. One neighbor built a fence between the two houses and the other built a bridge.

### **Circular Letter By: Josh Newsom**

Dear Brothers and Sister in Christ, friends, and family,

There have been many sleepless nights since being charged with writing this letter. It is a great responsibility, but honorable burden. I have many questions to ask and something I ask you to remember. Who is our example if not Christ? Where is Christ in us if we are without love, compassion, and mercy? As you go through life, remember what Paul wrote (Rom 3:23) "For all have sinned and come short of the glory of God." That doesn't leave out any man or woman that has reached the age of accountability or attained salvation.

I come before you a flawed man. Someone that has done many regrettable things. Yet, the Lord has been with me all the time. For this reason, I am humbled. As you read your Bible, I pray you read for understanding and not justification. Justifying our nature by the scriptures is easily done. God began to teach us from the beginning of time. If you aren't willing to listen а little closer, then how can you grow closer to him? (Gen 1:3-5) "And God said, Let there be light. And God saw the light was good: and God divided the light from the darkness. And God called the light Day, and the darkness He called night." Regardless of what we watch, read, or listen to, one thing stands out: light and darkness have always been contrary to the other. (Gen 6:6) "And it repented the Lord that he had made man on the earth, and it grieves him at his heart." (John 8:12) "Then spake Jesus unto them saying, I am the light of the world: he that follows me shall not walk in darkness but shall have the light of life." (John 3:19) "And this is the condemnation, that light is come into the world and men loved darkness rather than light, because their deeds were evil."

As we journey through life, we have but one job to do. Keep the commandments that our Lord and Savior set before us. (Matt 22:37-40) "Jesus said unto him, thou shalt love the Lord thy God

with all thy heart, all thy soul and all thy mind." This is the first and great commandment. The second is like unto it, thou shalt love thy neighbor as thyself. On these two commandments hang all the law and the prophets. To adhere to these commandments is a hard thing. We are but flesh and by nature are flawed.

I write this letter to warn each and every child of the King to be still in your actions, as well as your reactions. When we react one against another, we tend to adhere to our own nature. It is in our nature to believe we are right and everyone else is wrong. Where is Christ in that? How can we as Christians love our neighbor as ourselves without understanding first? I hope that you would remember to be as the "Good Samaritan". Be willing and eager to pick each other up when any have stumbled or fallen. Otherwise, we are in no better shape than the thieves that put them there and left them for dead.

In our flesh, we ALL continuously make mistakes. We stumble, fall, and do many things we ought not do. For this reason, we must hold tight to the things our Lord and Savior has taught us. The one thing that only He could. He taught us by showing us what Love truly is. How are we to Love without being compassionate and merciful? We cannot show love, compassion, or mercy without understanding first. We are none better than another or any less flawed. By our nature, we love darkness more than light. We continually try to find answers within ourselves; yet we have none. Brothers and Sister remember that Christ commanded us (John 13:34) "A new commandment I give unto you, that you love one another; as I have loved you." Don't be quick to judge and throw down. There is more to the commandment given (Exodus 20:13) "Thou shall not kill; than murder." We as Christians can kill someone's desire to be better. I believe that is what Paul was writing about in Corinthians chapter 8.

Brothers and Sisters, I plead with you to remember these things. Please show Love over judgment. We have all come from somewhere. We have all seen our brothers and sisters give way to someone who became cynical. Let go of your nature and the things of this world, it is all temporal. Make way for the spirit to move. Our Lord is forever. Paul writes (Gal 2:20) "I am crucified with Christ: nevertheless I live; yet not I, but Christ liveth in me: and the life which I now live in the flesh I live by faith of the Son of God, who loved me, and gave himself for me." ## Constitution

From a long series of experiences, we the churches of Jesus Christ, being legally baptized upon a profession of our faith in Christ, and convinced of the necessity of a combination of churches in order to have a union and communion among us, and preserve, perpetuate, and maintain a correspondence with each other in our union, we therefore propose to keep the order and rules of an Association, in accordance with the following plan, or form, of government:

**Article 1.** The Association shall be called the *Solid Rock Association of Old Time Baptist of Jesus Christ.* 

**Article 2.** The Association shall be composed of three (3) delegates from each church in our association, along with the elected officers. These delegates shall be duly sent to represent their church in the Association. They shall be members whom their church judge best qualified for that purpose. Upon producing letters from their respective churches, certifying their appointment, they shall be entitled to seats.

**Article 3.** Each church letter shall bear their annual statistics for numbers: in fellowship, baptized, received by letter, received by recommendation, received by restoration, dismissed by letter, dismissed by request, excluded and deceased.

**Article 4.** The delegates thus chosen and convened shall have no power to lord anything over God's children, nor shall they have any clerical power over the churches, nor shall they infringe on any of the internal rights of any church in our union.

**Article 5.** The Association, when convened, shall be governed by a regular and proper decorum.

**Article 6.** The Association shall have a Moderator, Assistant Moderator, Clerk and Assistant Clerk. Each shall be chosen separately by a majority vote of the delegates present.

**Article 7.** Any church petitioning, for either full membership or fellowship status, is to submit formal paperwork to the Association at the annual Solid Rock Association meeting. They will fall under the watch care of the Association's Committee on Council for an examination period of one year. If, at the conclusion of the examination period, they are found to be orthodox and orderly, per report by the Committee on Council, they shall be received by the Association, and manifested by the Moderator, who shall give them the right hand of fellowship.

**Article 8.** Every church in the union shall be entitled to representation in the Association.

**Article 9.** Every query presented by a church to the Association, being first debated in their own church, shall come under the consideration of the Association.

**Article 10.** Every motion made and seconded shall be considered by the Association, unless it be withdrawn by the party who made it.

**Article 11.** We think it absolutely necessary that we have an Association fund, for defraying the expenses of the same. We think it the duty of each church in the union to contribute such sums as they think proper, and to send it by their delegates to the Association. Such sums shall be deposited in the hands of the Treasurer, chosen by the Association, who shall be accountable for the money.

**Article 12.** There shall be an Association Book kept wherein the proceedings of every association shall be recorded by a Secretary appointed by the Association. The Secretary shall receive annual compensation for his services.

**Article 13.** The minutes of the Association may be read, and corrected if need be, and shall be signed by the Moderator and Clerk before the Association arises, unless the same is dispensed with. All queries, requests and resolutions which have been debated in the current association, shall be read back.

**Article 14.** Amendments to this plan of government can only be made by unanimous decision of the union, if deemed necessary.

**Article 15.** The Association shall endeavor to furnish the churches with minutes of the Association; the best method of effecting the same shall be determined by the Association.

**Article 16.** All matters coming before the Association shall be decided by a will of the majority of the delegates present.

**Article 17.** The Association is to remain as an advisory council, and not as an administrative government. Each church SHALL hold its own Ecclesiastical Keys. Each church shall be the sole judge of its members' conduct. Each church shall also have the right to decide who is worthy of membership, office or ordination.

Article 18. This Association shall have the power to:

**A**.) Provide for the general union of the churches, and to preserve an inviolable chain of communion between them;

**B**.) Give the churches all necessary advice in matters of church difficulty;

**C**.) Inquire into the cause as to why any church shall fail to represent themselves at any time in the Association;

**D**.) Appropriate the money contributed by the churches for any purpose it may think proper;

**E**.) Appoint any member, by their consent, to transact any business it may think necessary;

**F**.) Withdraw from any church in the union that does violate the Constitution, Articles of Faith or Rules of Decorum of the Association, or deviates from the orthodox principles of the Word of God as found in the book of Hebrews 6:1-2;

**G**.) To admit any orderly minister of our faith and order to a seat in the Association;

H.) To adjourn to any future time and place it deems convenient.

## **Articles of Faith**

Article 1. We believe in one true and living God (1 Cor 8:6): Father, Son and Holy Ghost (1 John 5:7); and these three are one (John 14:8-11).

**Article 2.** We believe the scriptures of the Old and New Testaments, as translated in the King James Version, to be the inspired written word of God (*2 Timothy 3:16; 2 Peter 1:21*). The New Testament is the standard of faith and the ONLY authorized rule of faith and practice to the church of God under the gospel dispensation (*Gal 5:4*).

**Article 3.** We believe in the doctrine of election by Grace (*Acts 10:43; Eph 2:8*). We do not believe in particular election (*Titus 2:11; Rom 10:13*) and reprobation, so as to make God partial directly, or indirectly, or to injure any of the children of men.

**Article 4.** We believe in the doctrine of original sin (*Rom* 5:12), and of man's inability to save himself from the fallen state he is in by nature; therefore, the Savior is needed for our redemption (*Rom* 5:17-19; *Eph* 2:8-9).

**Article 5.** We believe that sinners are called *(Mark 2:17)*, converted, regenerated and sanctified by the Holy Spirit *(1 Peter 1:23)*, and that all who are so regenerated and born again by the Spirit of God, shall never fall finally away *(Eph 1:13; Heb 10:14)*.

**Article 6.** We believe that sinners are justified in the sight of God *(Acts 13:39; Luke 18:13-14)* only by the imputed righteousness of Jesus Christ in obedience to the calling of repentance *(2 Timothy 1:9)*.

**Article 7.** We believe that baptism, the Lord's Supper and feet washing are ordinances of Jesus Christ *(Matt 3:13; Matt 26:26-29; John 13:4-14)*, and that true believers are the only proper subjects of these sacraments. And, we believe the only true mode of baptism is by immersion after receiving the spiritual baptism of the Holy Ghost *(Rom 6:4)*.

**Article 8.** We believe in the resurrection of the dead (*Luke* **24:46;** *I* **Cor 15:51-53**), and a general judgment, and that the joys of the righteous (1 Thess 4:16-17) and the punishment of the wicked will be eternal (*John* **5:28-29**).

**Article 9.** We believe no minister has the right to administer the ordinances of the gospel, unless He has been called (*Rom 10:15; 1 Cor 2:4*) and has come under the imposition of hands by a presbytery of the church (*Acts 13:2-3; Titus 1:5-15*).

**Article 10.** We believe that every doctrine that goes to encourage or indulge people in their sins (*1 Cor 5:2*) or causes them to settle down on anything short of saving faith in Christ for salvation (*Matt 7:13-14; Matt 7:21; Luke 13:23-24*), is erroneous and such doctrine shall be rejected by us (*Gal 1:8-10*).

**Article 11.** We believe that all people reaching the age of accountability must be born again *(Rom 7:9-10; John 3:3)*. We believe that all children dying in infancy, having not actually transgressed against the law of God *(Rom 4:15)*, are only subject to the first death which was brought on them by the fall of the first Adam. No child dying in that state shall suffer punishment in hell by the guilt of Adam's sin *(Matt 18:1-5)*.

**Article 12.** We believe that God is not willing that any should perish, but that all should come to repentance and the knowledge of the truth, that they might be saved *(2 Pet 3:9; John 3:16)*. All men, at one time or another, are found in such capacity as that through the grace of God they may be eternally saved *(Rom 5:18)*.

**Article 13.** We believe that Christ has but one true and gospel church, and that it will finally persevere through grace to glory *(Matt 16:18; 1 Cor 12:13)*. When the trump shall sound, the Son shall deliver up his church and present it to his Father, and so shall we ever be with the Lord *(1 Thess 4:16-17)*.

**Article 14.** We believe that the Church is a congregation of faithful believers in Christ who have obtained fellowship with the Lord and with one another (*Acts 2:41-42; 1 John 1:3*). Jesus Christ is the head of the church, and the government thereof is upon His shoulders (*Eph 5:23-24*).

## **Rules of Decorum**

Article 1. The Association shall be opened and closed with prayer.

**Article 2.** The Moderators and Clerks of the Association shall be selected by the delegates who are present.

**Article 3.** Only one member shall speak at a time and shall rise from his seat and address the Moderator when he is about to speak.

**Article 4.** The person speaking shall not be interrupted in his speech by anyone, except the Moderator, until he is done.

**Article 5.** The person speaking shall strictly adhere to his subject, and in no way reflect on the preceding speaker, but shall define his ideas on the proposition for debate so far as he can.

**Article 6.** No person shall abruptly absent himself from the Association without leave of the same.

**Article 7.** No member shall rise to speak more than three times on any one subject, without permission from the Association.

**Article 8.** No member of the Association shall have the liberty to laugh during the Association, nor whisper in time of public speech.

**Article 9.** No member shall address another in any other form or term other than that of "Brother" or "Sister."

**Article 10.** The Moderator shall not interrupt a Brother, or prohibit him from speaking, until he gives his views on the subject, unless he has violated the Rules of Decorum.

**Article 11.** The names of the several members of the Association shall be enrolled by the Clerk and called over as often as the Association may require.

**Article 12.** The Moderator shall be entitled to the same privilege of speech as any member, provided the chair be filled. But, he *shall have no vote*, unless the Association be equally divided. In this event, he shall give the deciding vote.

**Article 13.** Any member who shall willfully and knowingly violate any of these rules shall be reprimanded by the Association as it may think proper.

#### Resolutions

**Article 1.** We believe that our article of faith #10 rejects sin, including homosexuality. We also believe that marriage is a union between a man and a woman, neither of which gender has been altered. It is further agreed that our ministers refrain from marrying people into this ungodly sin. (Adopted in 2004 minutes)

**Article 2.** In regard to letters of dismission, the association recognizes the complexity of this issue and agrees that this request falls under article #17 of our constitution, which states: *The association is to remain as an advisory council and not as an administrative government. Each church shall be the sole judge of its members conduct. Each church shall also have the right to decide who is worthy of membership, office or ordination. (Adopted in 2004 minutes)* 

**Article 3.** We agree that several churches have already established a method of receiving previously ordained members into their fellowship. We recommend that the churches take care to uphold our articles of faith and constitution already established, particularly article of faith #9, and we note that the laying on of hands to issue credentials is an accepted practice with in our union. (Adopted in 2004 minutes)

**Article 4.** Under Article 7, any church organized under the authority of the Solid Rock Association, seeking membership, shall be immediately received and given the right hand of fellowship. This Article shall include any new associations seeking correspondence. Being a full member church of the Solid Rock Association grants voting rights to delegates, qualification to have members selected to preach the Introductory Sermon, and to write the Circular Letter. Fellowship churches only, are extended the right hand of fellowship as individual churches but do not have these authoritative rights. (Adopted in 2016 minutes)

**Article 5.** Under Article 14, the term "plan of government" pertains to the Association foundational documents including the Charter, Constitution, Articles of Faith, and Rules of Decorum. This does not apply to Article 16, which pertains to standard Association matters. (Adopted in 2016 minutes)

Daddy received the Presidential Unit Citation, The European-African-Middle Eastern Campaign Medal with Two Bronze Stars, the American Defense Service Medal, The American Campaign and the WWII Victory Medal and the Good Conduct Medal.

A good friend of Daddy's wrote to us about his experience with him. It was as follows: Arnold made such an impression on me from the first time I got to have Church with him. It was a pure joy to preach and sing with him. I loved to listen to him sing, he was just a humble little pilgrim who put his light on a candlestick some years ago. I believe the stronger man that Arnold had inside him shown through each and every day. The Lord said He would draw us with His love and kindness and I feel that the Lord used him well. I always received a Blessing being with him.
