Welcome to our Brunch With a Purpose x Black Girls Can Heal event! In preparation of your participation we would like to share a few details to make your experience enjoyable and successful. Please make sure that you read the entire document as you will be responsible for following all guidelines.

This Vendor Agreement (this "Agreement") is entered into by you, the vendor, (hereinafter, "you" or "Vendor") and Brunch With a Purpose Inc. and sets out the the terms and conditions governing your participation in the Brunch With a Purpose Inc. (each, an "Event"). By participating as a vendor at any Event you acknowledge that you have read and agree to the terms set out below.

Vendors may have access to event space beginning 1:00 pm. The event concludes at 6:00 pm and vendors have until 5:30 pm for break down. Participation in Brunch With a Purpose Inc. event is voluntary and vendors reserve all rights to their products and services as well as payment received for these products and services.

**Payment/ Registration Fee:** Payment shall be made directly through invoice link or with any major credit card. The Space Rental Fee is non-refundable, non-negotiable and non-transferrable. There are no refunds for absolutely any reason.

**Vendor Responsibilities:** In addition to any other Vendor requirements or restrictions as set forth in this Agreement, Vendor's must comply with the responsibilities set forth made a part of this Agreement, by Brunch With a Purpose Inc x Black Girls Can Heal Inc.

## **Vendor Responsibilities include:**

- Arriving on time for set up. Arriving after 1:00 PM will result in automatic forfeiture of your space.
- Vendor must promote their participation of pop up event.
- Vendor shall not request or pursue refunds for any reason.
- Brand shall participate with a positive attitude in an effort to promote community, positivity and entrepreneurship.



## **Booth Space:**

- (a) Assignment of Space. Following approval by Brunch With a Purpose Inc. and payment of the Rental Fee by Vendor, Brunch With a Purpose Inc. shall grant to Vendor approval to use **one** (1) **booth space** (5x5) **or** (10x10) (the "Space"). Vendor expo floor location is chosen on a first come first serve basis. Vendors reserve the right to request a different space, although it is not guaranteed. Vendor will be advised as to the location of the Space upon arrival at the venue during the appointed Vendor set-up period on the selling day. Vendor acknowledges that the size, location and configuration of the vendor spaces may vary. Brunch With a Purpose Inc. shall be entitled, in its sole discretion, to market, position and determine assignment of spaces to all vendors, including the Vendor, within the venue; and provided further that Vendor hereby accepts all such determinations as final. Vendor may not exceed the footprint of Vendor's designated Space.
- **(b)** There is no transfer, assignment, sub-licensing, subletting or sharing of the Space to other vendors or any other third parties in any form whatsoever. In addition, Vendor shall not market, display or sell merchandise of any third parties. In addition to any other remedies or recourse that Brunch With a Purpose Inc. may have hereunder or at law, if merchandise being displayed is determined to belong to a party other than the Vendor, without prior written approval from Brunch With a Purpose Inc., Brunch With a Purpose Inc. shall be entitled to terminate Vendor's rental and require that Vendor immediately vacate the Space and leave the venue.

**Limitation of Liability:** In no event shall Brunch With a Purpose Inc. and/or its affiliates and/or their respective members, managers, officers, employees, agents or representatives be liable to Vendor or any other person or entity for consequential, special, indirect, incidental, or punitive damages, costs, expenses or losses (including without limitation lost profits, loss of business, anticipatory profits and opportunity costs).



## **Brunch With a Purpose Inc. Pop-UP VENDORS ARE REQUIRED TO:**

- Set up their booths in a farmers' market style with tables, shelves, and/or rolling racks facing out
- Wipe down surfaces hourly with disinfecting wipes
- Maintain 6' distance from other vendors and attendees
- Limit the number of staff in their booth to 2 people, including themselves
