

# 2024 Cowboy Care Coalition Fundraiser/Sweepstakes

## Official Sweepstakes Rules

NO PURCHASE/DONATION NECESSARY TO ENTER OR WIN. A PURCHASE OR DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING.

GENERAL: In these Official Rules, “you” or “your” or “entrant” means the person who has entered this Sweepstakes. By entering in this Sweepstakes, you agree to be bound by: (i) the terms and conditions contained in these Official Rules; and (ii) any and all decisions of Sponsor in all matters relating to this Sweepstakes. Sponsor reserves the right in its sole discretion to permanently disqualify any entrant it believes has violated these Official Rules. This Sweepstakes is governed by U.S. law and subject to all applicable federal, state and local laws and regulations.

SWEEPSTAKES ENTRY PERIOD: This Sweepstakes begins at 12:01am CST on July 1, 2024 and ends at 1:45 pm CST on October 5, 2024 (the “Entry Period”).

HOW TO ENTER: To enter this Sweepstakes, (1) Visit the Cowboy Care Coalition Facebook page(<https://www.facebook.com/cowboycarecoalition>), and (2) like and share our post promoting this sweepstakes, (3) Go to our website (<https://cowboycarecoalition.org>) and complete the entry form, (4) print the entry form and mail it, along with a self addressed, stamped envelope to Cowboy Care Coalition Sweepstakes, 547 S 2nd Street Bellaire, Texas 77401. We will in turn mail your sweepstake ticket to you. The odds of winning depend on the total number of qualifying entrants. In the event of a dispute concerning entries submitted by multiple individuals using the same account, the entry will be deemed to have been submitted by the authorized subscriber of the account used to enter the Sweepstakes.

ELIGIBILITY: This Sweepstakes is sponsored and administered by Cowboy Care Coalition, Inc., (“Sponsor”). DETERMINATION OF WINNERS: The drawing will occur at the end of the Entry Period above under the supervision of the Sponsor whose decisions are final and binding in all matters pertaining to this Sweepstakes. Prize Winners will be contacted via a responsive comment from Sponsor within approximately seven (7) days after Prize Winners are selected and must reply to the notification within seven days, or the prize will be forfeited and an alternate winner will be selected.
