- By participating in the above named event, I understand that I am participating at my own risk. I will not hold the Hallstead Volunteer Fire Company ("HVFC"), its members, their heirs, successors, or assigns, any emergency medical service providers, or the landowners upon which the event takes place, their heirs, successors, or assigns, responsible for any injury or death to me or to another caused by me or damage that may occur to my property or the property of others that may occur as the result of my participation in the event including, but not limited to assistance in parking or removal of vehicles / trailers from parking lots. In the event your property is required to be towed by an outside source you acknowledge you are responsible for all costs involved and HVFC is not liable for any damage that may occur.
- All litter must be disposed of properly and not thrown along the trail. Waste receptacles will be provided at stations on the ride.
- I acknowledge that it is dangerous to consume alcohol and ride an All-Terrain Vehicle ("ATV") and understand that the fire company stipulates that no alcohol be consumed during this event. I will ride in a safe and appropriate manner at all times. I understand that law requires helmets and the fire company will require helmets to be worn at all times while riding in the event.
- All laws pertaining to ATVs must be followed. It is my responsibility as a rider in this event to know these laws and be compliant with them.
- REGISTERING FOR THIS EVENT DOES NOT EXEMPT ANY RIDER FROM OBEYING ANY AND ALL LAWS GOVERNING THE PROPER USE, REGISTRATION, LICENSING AND ANY OTHER LAWS REGULATING ATV USE IN THE COMMONWEALTH OF PENNSYLVANIA.
- HVFC agrees not to provide the information below to anyone except law enforcement and emergency services acting in an official capacity.
- Please be aware that traveling on the landowners' properties that have graciously offered their land for our trail ride is only allowed during the Poker Run. Under no circumstances will anyone be allowed on anyone's private property after the event has been held. Any rider or participant who does not comply with this condition or any conditions listed herein will be immediately asked to leave the event and will not be allowed to return.
- Please note: We do not inspect any ATVs for registration. It is your individual responsibility as owner/rider to be compliant with any appropriate laws and regulations pertaining to the ownership and use of All-Terrain Vehicles. The Commonwealth of Pennsylvania requires that all ATVs must be registered and insured except in certain circumstances. Please remember that we do not inspect ATVs and expect you to be compliant.
- If you venture off the trail, get lost, etc., you are not under the blanket of the ride and can be fined for trespassing. **PLEASE NOTE: The landowners for this event allow us to utilize their land for the benefit of HVFC only. Please be respectful of their land.** If you are inspected by any law enforcement agent, fines and other penalties can be imposed for non-compliance. As a reminder, when riding an ATV, you are not immune from DUI charges. Pennsylvania State Police investigate each and every ATV accident. Just a reminder!
- Anyone, rider / participant under 18 years of age must have a parent /guardian signature. Please adhere to all COVID guidelines. If you do not feel well, please stay home!
- The Poker Run will proceed rain or shine! **Have a great day and enjoy the run!**
