POLITICIZE THE CIVIL SERVICE

- ➤ The Trump Administration issued Executive Order 1395724 to make career professionals in positions that are not normally subject to change as a result of a presidential transition but who discharge significant duties and exercise significant discretion in formulating and implementing executive branch policy and programs an exception to the competitive hiring rules and examinations for career positions under a new Schedule F. (Pg 80)
- > 4,000 current political appointees
- > Schedule F increases that to 50,000 or more

GOVERNMENT

- Move compensation for Government roles to private market model (Pg 77)
- Reduce impact of unions in government jobs (Pg 81)
- Dismantle Department of Homeland Security (Pg 133)
- > Privatize Transportation Security Administration (TSA) (Pg 134)

EDUCATION

- **Eliminate the Department of Education (Pg 319)**
- Allow State control over federal education funding (Pg 322)
- No student loan forgiveness (Pg 322)
- No civil rights protections for LGBTQ+ students (Pg 322)
- Rescind requirements and lessen federal restrictions on charter schools (Pg 331)
- Define "sex" under Title IX to be only "biological sex recognized at birth" (Pg 333)



MAKE COLLEGE UNAFFORDABLE

- > Deny Student Loan access to students at schools that provide instate tuition to "illegal aliens" (Pg 167)
- Privatize all lending programs, including subsidized, unsubsidized, and PLUS loans (Pg 353)
- **▶ Eliminate Grad PLUS loans (for graduate students) and Parent PLUS loans (for parents of undergraduates) (Pg 354)**

RESTRICT OVERTIME

- Lower the Overtime pay threshold, reducing the number of roles eligible for overtime when they work more than 40 hours in a week (Pg 592)
- Estimated to impact at least four (4) million workers in 2025
- ➤ Calculate the overtime period over a longer number of weeks (currently more than 40 in one week) to allow employers the ability to mitigate a higher hour week with a lower one, paying more hours at straight time (Pg 334)

WEAKEN CHILD LABOR PROTECTIONS

- DOL should amend its hazard-order regulations to permit teenage workers access to work in jobs rated as "inherently dangerous" (Pg 595)
- Young people entering the labor force out of economic necessity could be subjected to more dangerous work because they need the income more than others and cannot access a safer job or get paid as well.

HARDER TO MAKE ENDS MEET

- Eliminate the Head Start Program (Pg 482)
- Impose Work Requirements to receive SNAP benefits (Pg 299)
- Reduce costs of providing benefits to veterans by revising disability ratings (meaning less things are covered) (Pg 650)
- Repeal all Title I farm programs (ARC, PLC), don't pay for price losses and revenue losses in the same year, reduce premium subsidy rate for crop insurance (Pg 296-97) All this because farmers are just flat out making too much;-)
- Eliminate funding for public transportation projects (Pg 635)



GETTING THE CARE YOU NEED

- Remove Medicare's ability to negotiate lower prescription prices (Pg 465)
- Make delivery via mail of medications for abortion illegal (Pg 562)
- Reverse the FDA approval of mifepristone and requiring it to only be dispensed in person and via prescription (Pg 458-59)
- Pushing toward private Medicare plans that often have worse outcomes (Pg 463)
- Removing HIPAA guidance that providers are not required to disclose patient private info to law enforcement (Pg 497)
