

**VILLAGE OF BLOOMINGTON
ORDINANCE NO. 2022-02**

**AN ORDINANCE TO AMEND CHAPTER IV (FOUR) ENTITLED "TRAFFIC CODE"
SECTION 4.07 ENTITLED "PARKING", SUBSECTION 4.07(2) "PARKING LIMITS"
OF THE VILLAGE OF BLOOMINGTON MUNICIPAL CODE.**

NOW, THEREFORE, the Bloomington Village Council of the Village of Bloomington, Grant County, Wisconsin, does ordain as follows:

Section I: Chapter IV (Four) entitled "Traffic Code", Section 4.07 entitled "Parking" to amend Subsection 4.07(2), "Parking Limits" of the Village of Bloomington Municipal Code shall be and hereby is amended as follows:


4.07(2) Parking Limits. – When signs are erected in any block giving notice thereof, no person shall park a vehicle for longer than a period of two consecutive hours at any time between the hours of 8:00 a.m. and 6:00 p.m. on any Monday, Tuesday, Wednesday, Thursday, or Friday, or between the hours of 8:00 a.m. and 1 p.m. on any Saturday, upon the following streets or portions of streets:

- (a) Both sides of Canal Street between Pleasant Street and Mill Street excepting that part of the North side of said portion of Canal Street which adjoins the South side of Lot 7, Block 2 of Original Tafton. Bloomington (being that portion of said street lying along the front of the United States Post Office property) where no person shall park a vehicle for longer than a period of five minutes at any time between the hours of 8:00 a.m. and 6:00 p.m. of any day except Sundays or legal holidays.
- (b) Both sides of Pleasant Street between Canal Street and First Street.
- (c) Both sides on Congress Street between Canal Street and First Street.


Section II: This Ordinance shall take effect upon its passage and publication or posting as required by law.
