

**VILLAGE OF BLOOMINGTON
ORDINANCE NO. 2026-02**

AN ORDINANCE TO AMEND CHAPTER II (TWO) ENTITLED "RULES AND PROCEDURES OF THE VILLAGE BOARD," SECTION 2.01 ENTITLED "BOARD MEETINGS" PARAGRAPH (1) "REGULAR MEETINGS", AND SECTION 2.03 ENTITLED "RULES OF BOARD PROCEDURE" PARAGRAPH (1) "STANDING COMMITTEES" TO THE VILLAGE OF BLOOMINGTON MUNICIPAL CODE.

NOW, THEREFORE, the Village Board of the Village of Bloomington, Grant County, Wisconsin, does ordain as follows:

Section I: Chapter II (Two) entitled "RULES AND PROCEDURES OF THE VILLAGE BOARD," Section 2.01 entitled "Board Meetings" paragraph (1) "Regular Meetings" of the Village of Bloomington Municipal Code shall be amended as follows:

2.01 BOARD MEETINGS

(1) REGULAR MEETINGS

The regular meetings of the Village Board of the Village of Bloomington shall be held in the library room of the Municipal Building in the Village, on the second Wednesday of each month at 6:00 o'clock in the evening, except that when the date for holding any regular meeting shall be a legal holiday or election day, the regular meeting shall be held at the same time and place on the second Thursday of the month.

Section II: Chapter II (Two) entitled "RULES AND PROCEDURES OF THE VILLAGE BOARD," Section 2.03 entitled "Rules of Board Procedure" paragraph (1) "Standing Committees" of the Village of Bloomington Municipal Code shall be amended as follows:

2.03 RULES OF BOARD PROCEDURE

(1) STANDING COMMITTEES

The following standing committees of the Village Board shall be appointed by the President subject to confirmation by the Board at the Board's meeting in the month of May following the municipal election in odd-numbered years or as soon thereafter as can be, and shall consist of three (3) Board members each, the first person named on each committee to be the chairman there:

- A. Finance and Administration Committee
- B. Public Works and Utilities Committee
- C. Public Safety Committee
- D. Parks and Grounds Committee
- E. Personnel Committee.

Section III: This Ordinance shall take effect upon its passage and publication or posting as required by law.
