

**VILLAGE OF BLOOMINGTON
ORDINANCE NO. 2026-07**

**AN ORDINANCE TO AMEND CHAPTER VI (SIX) ENTITLED "PUBLIC CONDUCT"
TO AMEND SECTION 6.04 ENTITLED "OBSTRUCTING STREETS AND SIDEWALKS
PROHIBITED" OF THE VILLAGE OF BLOOMINGTON MUNICIPAL CODE.**

NOW, THEREFORE, the Village Board of the Village of Bloomington, Grant County, Wisconsin, does ordain as follows:

Section I: Chapter VI (Six) entitled "Public Conduct," Section 6.04 entitled "Obstructing Streets And Sidewalks Prohibited" of Village of Bloomington Municipal Code is hereby amended as follows:

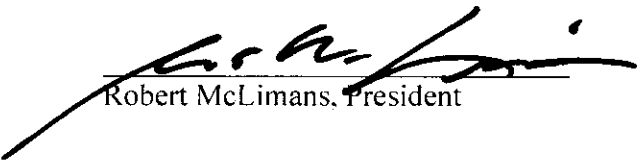
6.04 – OBSTRUCTING STREETS AND SIDEWALKS PROHIBITED

- (1) No person shall stand, sit, loaf or loiter or engage in any sport or exercise on any public street, sidewalk, bridge or public ground within the Village in such manner as to prevent or obstruct the free passage of pedestrian or vehicular traffic thereon or to prevent or hinder free ingress or egress to or from any place of business or amusement, church, public hall or meeting place.
- (2) The use of all electric/motorized and manually operated bicycles, scooters, skateboards, skates and other such devices, shall be strictly prohibited on the sidewalks in the commercial business area identified as Canal Street, from Mill Street to Pleasant Street, within the Village of Bloomington. This identified area of Canal Street is for foot traffic only. This restriction is intended for the safety of all persons, to protect pedestrians, prevent collisions, and manage congestion in the commercial zone. Operators of bicycles, scooters, and skateboards are expected to dismount and walk their equipment through this restricted commercial business area. Mobility devices for the disabled are exempt from this restriction.

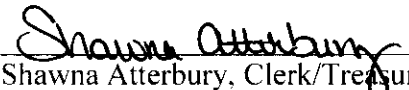
Section III: This Ordinance shall take effect upon its passage and publication or posting as required by law.
