Before and After School Care (Kindergarten – 12th Grade)

Parents/Guardians must complete an Extended Care Form indicating which services are required for the monthly rate to apply. The student’s account will be automatically billed for these services, and payment is due on the 1st of each month. The monthly rate will apply as a convenience regardless of the number of times the service is utilized. It is the parent’s responsibility to update and submit a new form when there is a service change.
