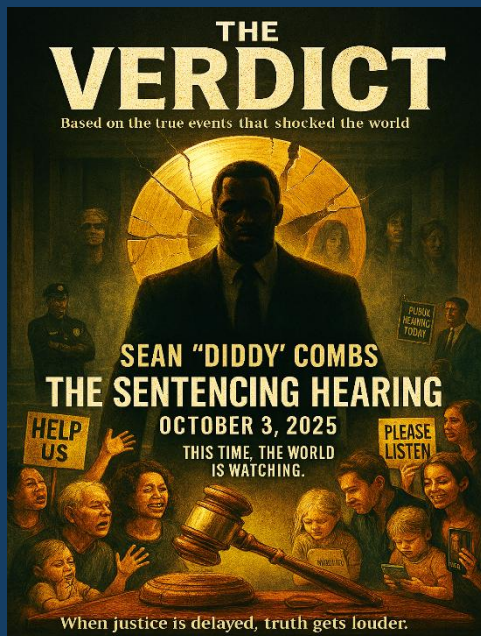

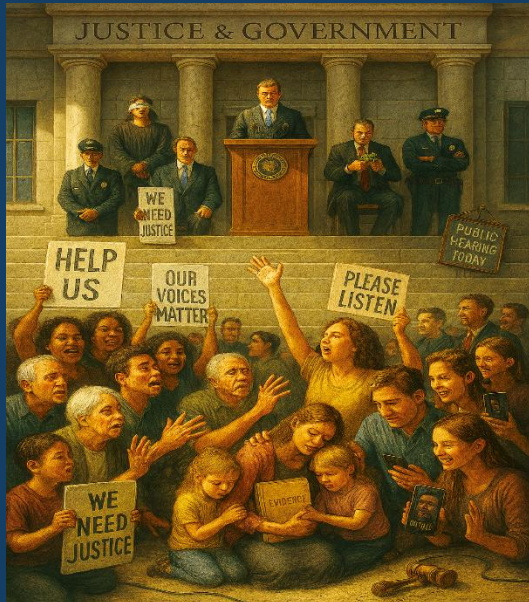
As the nation awaits the sentencing hearing of Sean “Diddy” Combs, the question is no longer just about guilt or innocence; it is about whether justice itself is still alive.
